Board met at 10 o'clock A. M. this 6th day of September, A. D. 1921, in regular session as is by law required, Roll Call showing present Andy Nelson, David West and Wm. A. McKay, Chairman Board of County Commissioners and Malinda Miller Clerk.

PROCEEDINGS WERE HAD AS FOLLOWS, TO-WIT:

The Minutes of the previous sessions were read and approved.

On account of the death of Mrs. Fred Johnson, Superintendent of the County Poor House, the County Commissioners appointed Fred Johnson to Act as said Superintendent.

The Clerk was instructed to advertise the location and Establishment of a County Road East of Medicine Bow, Wyoming, more particularly described by the Surveyor's Field Notes, as follows, to-wit:

COUNTY ROAD EAST OF MEDICINE BOW, WYOMING.

Beginning at the North Quarter Corner of Section 11, T. 22 N. R. 78 W of the 6th P. M.;

Thence West along section lines between sections 2 and 11, and 3 and 10, to a point 420 feet east of the Quarter corner between sections 3 and 10;

Thence S. 68° 00' W. 453 feet to the north and south center line of section 10; thence south along the north and south center line of said Section 10, 870 feet to old Union Pacific Grade;

Thence along old Union Pacific Grade as follows:

N. 88° 30' W. 670 feet;

S. 80° 30' W. 900 Feet;

S. 80° 00' W. 2550 feet;

S. 89° 15' W. 2260 feet to a point on the Lincoln Highway which point bears N. 58° 00' E. 1930 feet from the West quarter corner of Section 9, T. 22 N. R. 78 W of the 6th P. M.
