BIDS.

Pursuant to call for Bids for the leasing of the County Poor Farm at Dixon, Wyoming and the Boarding and Caring of the inmates, the hour of 12 o'clock Noon having arrived, bids were opened and read as follows:-

R. E. DAVIS. For furnishing three meals each day for each inmate at the rate of 50¢ a day. For the care of the rooms, washing and mending at the rate of \$2.00 a day. Also agree to furnish all Fuel used. To make repairs to fence and buildings, with material to be furnished. In case land is for rent agree to tend and harvest crop for one-half of crop; in case water is provided agree to pay the sum of \$250.00 each year.

MRS. G. W. REED.

For boarding and caring for the inmates at the rate of 15¢ per meal and will pay \$150.00 annual rent on the Poor Farm. In case of sickness when patient remains in bed, \$2.00 per day. Also \$60.00 a month salary over and above this bid.

Mrs. FRED JOHNSON.

For furnishing three meals each day for each inmate for 20¢ a meal and to care for inmates giving them good substantial food. Also to pay \$300.00 for lease of poor farm per year, if poor farm is to be rented.

All bids having been read and considered Motion was made by Commissioner West and Seconded by Commissioner Nelson that contract for the Running of the Poor Home be given to Mrs. Fred Johnson of Dixon, Wyoming, upon the signing of an agreement and she also to furnish Bond to be approved by the Board. Roll Call of Vote; Commissioners West, Nelson and McKay all voting aye.

Upon further discussion the board of Commissioners instructed the Clerk to request that all bills to the poor home be mailed to Mrs. Fred Johnson for approval and sent into the County Clerk's office by her.

BURIAL OF PAUPERS.

Motion was made by Commissioner Nelson that the sum of Sixty-five (65) Dollars be allowed for the burial of paupers. Seconded by Commissioner West. Motion made and Seconded that the set sum of \$65.00 to be allowed in the future for burial of paupers.

It appearing to the Board of County Commissioners that Geo. Gideon of Baggs, resigned his office as Deputy Sheriff, Lawrence Dolan was duly appointed to take his place.

Application for DEPOSIT OF PUBLIC FUNDS in the STOCKMEN'S/BANK of MEDICINE BOW, WYOMING, was read and duly put to motion. Motion made and second that Stockmen's State Bank be appointed a depository for Carbon County funds.
