PROCEEDINGS WERE HAD AS FOLLOWS:-

CANVASS OF RETURNS OF ELECTION OF PLATTE VALLEY HIGH SCHOOL DISTRICT, BY BOARD OF COUNTY COMMISSIONERS OF CARBON COUNTY, WYOMING.

WHEREAS, on the 18th day of November, A. D., 1922, pursuant to proclamation, notice and call, by the Board of County Commissioners of said county of Carbon, Wyoming, an election of all the qualified electors residing within the respective school districts hereinafter set forth, was had and held in each of said school districts hereinafter set forth, in said county of Carbon, Wyoming, on the said 18th day of November, A. D., 1922, commencing at the hour of two o'clock P. M., whereat there was submitted to qualified electors in each of said districts, the proposition and question of the organization and creation of a high school District, to be known as, "PLATTE VALLEY HIGH SCHOOL, STATE OF WYOMING". And,

WHEREAS, the said school districts wherein said vote was so had upon said proposition as aforesaid, and on the said 18th day of November, A. D., 1922, as aforesaid, pursuant to said proclamation, notice and call thereof in each district as aforesaid, and at the place mentioned in said proclamation in each district, such election was had and held in the following school districts to-wit:

In School Districts, Carbon County, Wyoming, being School District No. 30, School District No. 23, School District No. 35, School District No. 17, School District No. 26, School District No. 9, School District No. 18, School District No. 8, School District No. 22, School District No. 13 and School District No. 10, and,

WHEREAS, the judges of election in each of said school districts as aforesaid, pursuant to law, did canvass the said votes in each of said districts as aforesaid, and did make their returns thereof, and pursuant to law did forward said returns of each of said districts of the respective votes cast therein, to the County Clerk of Carbon County, Wyoming, and that said returns and canvass of each of said school districts as aforesaid, are here and now before the Board.

Now, therefore, on this 6th day of December, A. D., 1922 the Board of County Commissioners of said county of Carbon, being in regular session, at the usual meeting place of the Board, at the Court House, in the city of Rawlins, in said County of Carbon, Wyoming, now having before said Board all of the returns and ballots so cast in each of said school districts as aforesaid, unopened, and upon order duly made, the Clerk was directed to open the said returns from each of the said school districts as aforesaid, and said returns and the ballots cast thereat are now before the Board.

The said Board of County Commissioners of Carbon County, Wyoming, did on this day, immediately canvass said returns and the ballots cast in each of said school districts as aforesaid, upon the organization and creation of said high school district,

The said Board of County Commissioners, upon the completion of the said canvass of said returns and ballots cast as aforesaid, now makes its official canvass thereof as follows:

Upon motion duly made, seconded and unanimously carried by the Board of County Commissioners of the County of Carbon, Wyoming, it is ordered, declared and determined, that said High School District, known as "Platte Valley High School, State of Wyoming," is hereby created, and the said High School District ~~xxxx~~ to be composed of all those school districts in which a majority vote was for the creation and organization of said High school districts as aforesaid, to-wit:

All of said School District Nos. 30, 23, 35, 17, 26 and 9, in said County of Carbon, Wyoming.

That the territory embraced in said High School District, as aforesaid, wherein a majority vote was cast as aforesaid, is particularly described by Townships and Ranges and Fractions of Townships and ranges, as follows, to-wit:

School District No. 30, All of Sections 22, 23, 24, 25, 26, 27, 34, 35 and 36, in Twp. 16 N. R. 84.
