ROAD AND POLL TAX.

Regarding the matter of the Collection of Poll and Road Taxes by the Assessor at the time of assessment, it was regularly moved by and seconded by the Board of County Commissioners that all persons between the age of Twenty-one and Fifty years, inclusive, pay a Poll Tax of (\$2.00) Two Dollars for School Purposes in accordance with Section 2752 of the Wyoming Compiled Statutes of 1920, and also that each able-bodied man in the County between the age of Twenty-one and Fifty years, inclusive, pay a Special Road Tax of Two (\$2.00) Dollars according to Section 3053 of the Wyoming Compiled Statutes of 1920. Motion Carried.

THE matter of estimating the costs of maintaining the County Government for the year, 1922, in compliance with Section 1366 of the Compiled Statutes of Wyoming, 1920, was considered and after due calculations apportionment was made as follows;-to-wit:
