

The BOARD OF COUNTY COMMISSIONERS met this fifth day of June A.D.1923 in regular session with all members present and David West in the chair.

The County Attorney advised the board as to the action of the district court in regard to the refundment of taxes in School District No.20, which case was up before the board on February sixth 1923.

After due consideration the motion was duly made and carried that the certificate of indebtedness which was issued at that time to cover the said tax refund be withdrawn and the Treasurer be instructed to pay to W.F.Daley, as Trustee the sum of \$491.73 in the amounts set opposite the following names as per the judgment set forth by the district court on March 7th, 1923 to-wit:
