

BOARD OF COUNTY COMMISSIONERS ,with all members present met this 6th,day of August A.D.1923 for the special purppse of fixing the TAX LEVY.

At the outset the board was in receipt of a telegram from the State Board of Equalization advising that the Assessor must raise the valuation on all town lots and improvements in Carbon County. They therefore decided that inasmuch as the Assessor had already finished ~~the~~ this work and that it would cause a delay of several weeks to meet the requirements of the State Board,they adjourn the meeting for making the levy until such time as the assessor shall have completed the revision.

Motion for adjournment carried.

August 7th,1923 the Board of Coqnty Commissioners met in regular session for the transaction of such business as should come before it.

The vote for trustees for the Platte Valley High School was presented to the board for canvas and ^{over} after looking the returns carefully they named the following parties as having been elected: A.J.Kennaday, D.E.Winsor, A.B.Walker, H.G.Mowry, R.H.Pearson, B.T.Carroll, and directed the clerk to supply the above named trustees with certificates of election.

At two o'clock the board met for regular business and to open the bids for the three steel bridges which were advertised for at last session.

On motion by C.W.Morgan seconded by A.Nelson it was decided to have the terms or the ^{read} contract~~s~~ previous to opening the bids,after which time the following bids were opened and placed on record: D.B.Miller of Cheyenne and Denver \$22870.00; Missouri Valley Bridge and Construction Co. \$23766.00; Midland Bridge and Construction Co. \$30700.00; Monarch Engineering Co. \$23428.00; Colorado Bridge and Construction Co. \$23997.00 Regularly moved and seconded and carried that the bid of Mr.D.B.Miller be accepted.

Motion carried for recess untill the 8th,August at ten A.M.

PETITION FOR THE REMOVAL OF OBSTRUCTIONS AND OPENING UP OF THE OLD PUBLIC ROAD from Savery Creek over Brown's Hill. In response to the above petition which was signed by the users of the above mentioned road, it was moved by D. West, seconded by C.W. Morgan and carried that the road supervisor be instructed to proceed to the vicinity of the Savery - Brown's Hill road and take such action as should be necessary to have the obstructions removed and the road opened up for public use.

Acting on the PETITION FOR A COUNTY LIVE STOCK INSPECTOR which was carried over from the previous session it was moved by C.W. Morgan, seconded by A. Nelson and carried that A.J. Kennaday be appointed County Stock Inspector and Carl Dolan of Medicine Bow be deputy County Stock Inspector, and the clerk was instructed to issue certificates of Appointment to the appointees.
