Meeting adjourned.

Immediately following the adjournment of the old board the new board went into session with the following answering roll call: David West, Andy Nelson and C.W.Morgan as Commissioners and J.E.Buchanan , Clerk.

On motion made, seconded and carried David West was elected Chairman of the Board.

The following appointments were approved by the Board: Mrs.Linda Felton, deputy County Clerk and Miss Anna Miller, assistant; William L Wallace, Deputy Treasurer; Louise Irving, deputy Superintendant of Schools; W.P.Mills, Under Sheriff, and L.J.Dolan of Baggs, John Terrill of Dixon, Roy C.Peck of Saratoga, Z.T.Carver of Encampment, C.E. Cooper of Medicine Bow, Evan Jones of Hanna and Fred Hansen of Elk Mountain as Deputy Sheriffs of their respective districts.

Application of Dr.E.A.Kell of Rawlins for the position of County Physician was considered and approved.

Motion by D.West and seconded by A.Nelson and carried that the Rawlins Republican be named as the County Official Paper for the publication of all necessary notices and that the necessary book and stationery supplies be purchased from them when their prices were as reasonable as those of other firms.

Inspection of the condition of the Court House building made.

On motion the meeting adjourned until February 6th, 1923.
