

BOARD OF COUNTY COMMISSIONERS met this 6th, day of February A.D.1923 as by law required, at ten o'clock a.m. with all members present and Chairman D. West in the Chair.

Publication of the Appropriations for the present year were ordered which were as follows:

Mr. Tol. Griffey appeared before the board with a petition asking that a part of school district # 7 be placed in school district #6 in order that the children of the petitioners be able to have the advantage of a school. Parties seeking relief are located in sections #19 to #36 inclusive, township #23 and range #79, and sections #1 to #36, township 22, range 79. After due consideration it was decided that as a preliminary move the superintendent of schools be requested to take the matter up with the Hanna school district.

Bonds of the following elected officials were inspected and approved: Ed. Dinger, Deputy sheriff of Fort Steele, Dr. C. W. Jeffray, coroner, J. P. Shehan constable, Rawlins, E. R. Watson justice of the peace, Rawlins, and W. L. Wallace, deputy treasurer.

Board recessed from 12 o'clock until 2 at which time applications for abatement of county taxes were considered and the following were allowed: Andrew Clifford, in full \$34.21; J. M. Sowder, Saratoga, abated \$6.44; Paul Paulsen, agent for the Wyoming Mine & Development Co. abated \$39.83; Rev. Harold Johns, in full \$4.29; and Saratoga Live Stock Co., abated \$7.38.

Anent the School Tax Entanglement of School District number 20, the following resolutions were ordered incorporated in our proceedings:

WHEREAS, suit was filed in the District Court of Carbon County, Wyoming, on April 16, 1921, by William T. Peryam, Creve Peryam, John T. Peryam, Joseph Peryam, Mrs. A. R. Peryam and J. F. Wilcox, Plaintiffs, vs. S. Park, Will F. Daley, The Board of County Commissioners of Carbon County, Wyoming, and School District No. 20 in the County of Carbon and State of Wyoming, Defendants, praying for the cancellation of a tax levy made at the School meeting by School District No. 20, on May 3, 1920, and

Whereas, said cause came on regularly for trial before the District Court of Carbon County, Wyoming, on March 7, 1922, and judgment was entered against the above named Defendants, and in favor of the Plaintiffs, and said tax levy declared null and void, and the County Treasurer of Carbon County, Wyoming, was ordered to pay, and the County Commissioner of Carbon County, Wyoming, and The Board of County Commissioners were ordered to rebate and refund all monies paid by the Plaintiffs herein to the County Treasurer of Carbon County, Wyoming, by reason of the illegal levy as aforesaid, and

WHEREAS, the County Treasurer has provided the Board of County Commissioners of Carbon County, Wyoming, with the following names of the tax-payers in School District No. 20; and the amounts of the taxes paid in under the illegal levy to be refunded, the same totaling Six Hundred Thirty-four Dollars and 67/100 (\$634.67) and
