

BOARD OF COUNTY COMMISSIONERS met this 6th, day of May A.D. 1924 at ten o'clock a.m., with all members present and David West in the chair.

Mr. A.M. Startzell appeared before the board in support of opening up the road from Purgatory Gulch into Encampment and strongly urged its consideration by the Board. The proposition was taken under advisement.

Mr. Whetmore of the Union Pacific freight department appeared before the board and urged that the county at its earliest convenience take steps to have the Wamsutter Baggs road put in good condition.

In re the Encampment-Slater road through the National Forest the following motion was made by Andy Nelson, seconded by C.W. Morgan and carried unanimously:

That Carbon County appropriate \$2000.00 additional for the Encampment-Slater road subject to the fact that the State shall pay in \$4000.00 additional for the same project and the Forest Service put in \$18,000.00 on the same project, and that the \$12,000.00 already on deposit from Carbon County, all be used this year on this project in accordance with the terms of the telegram on file in this office from the District Forester to the Forest Service at Encampment.

After due consideration it was moved by C.W.Morgan,seconded by D.West and carried that they be allowed \$15,000.00.


