

BOARD OF COUNTY COMMISSIONERS OF CARBON COUNTY met this 3rd, day of June, A.D. 1924 at ten o'clock a.m. with all members present and David West in the chair.

A strong delegation of the business men of Rawlins appeared before the board at this time and strongly urged early action on the Rawlins-Snake River road with the view of placing that highway in a passable condition for the accommodation of the increased traffic, incident to the oil development in the country south of this section of the county,.

The case was very ably presented by Mr. L. E. Armstrong and the proposition was taken under advisement as it would be necessary for the commissioners to look over the requirements of that route before any decision could be reached in the matter.


