

Board of County Commissioners met this 4th day of March A. D. 1924, at 10 o'clock A. M. with all present and D. West in Chair.

In re: Rocky Mountain Highway:

Upon motion by Mr. Morgan, seconded by Mr. Nelson the following resolution was unanimously adopted:

Whereas the description of the Rawlins-Casper Road has been duly advertised as ordered by this Board in three successive issues of the Rawlins Republican viz: Dec. 13, 20, and 27th 1923, said description being as follows:
