By Motion duly made and carried Board Recessed to meet on November 4th at 10:00 o'clock A. M.

The Board resumed its session this 4th day of November 1925, with all member present;

By motion duly made and carried R. W. Duncan was rebated the amount of Penalty on tax assessment on his trucks in the amount of \$50.96.

The Board then took into consideration the report of the Damage Award as brought in by the Arbitration Board to assess the damages sustained by S. J. Sharp to his property by the construction of the Rocky Mountain Highway thru Muddy Gap.

After due consideration of said report the Board by motion duly made and carried agreed to accept said award which was as follows:

That the Board of County Commissioners should pay Mr. Sharp the sum of \$300.00 and in addition vacate and abandon the old County Road thru Wiskey Gap; and on motion made by W. M. Englehart seconded by P. L. Gooldy and duly carried this Board agrees and hereby orders that the sum of \$300.00 be paid to Mr. S. J. Sharp and in addition that the road here below described and known as the Wiskey Gap road be vacated and abandoned to Mr. Sharp, as far as his interests lie:

Beginning at Intersections of Rawlins, Casper Highway (C. B. 10) 2250 ft. N. of S. Line Sec. 23 Township 27N. R. 89 West: Thence N. Easterly thru Sec. 14-13-12 and 1. Township 27N. Range 89 West. Thence N. E. thru Sec. 36 TS 28 N. R. 89 West. Thence thru Sec. 31-32-29-28-21-22-15-14-11-12 and 1. Towns: 28 N. 88 W. Thence thru 6 TS 28 N. R. 87 W and Sec. 32 TS 29 N. R. 87 West., intersecting Rawlins Casper Highway 1875 ft. west of E. Line Sec. 32. TS 29 N. R. 87 West.

Responding to an application of the Producers & Refiners Corporation for Right of Way for Simpson Ridge Oil Pipe Line across Hanna-Elk Mountain Road it was regularly moved and carried that such Right of Way be granted to the Producers & Refiners Corporation for a Right of Way across said road at such points as are indicated by the plat on file in the office of the County Clerk under Nos. PL 907 and PL 908 for such time as they shall continue to use same for the transportation of oil.
