

ROAD

Board of County Commissioners met this 3rd Day of Feb. at 10 o'clock A. M. with all members present and Chas. W. Morgan in the chair.

The alteration and establishment of the proposed Rocky Mountain Highway between Saratoga and Encampment, Wyoming, was taken up for consideration.

After general discussion it was then moved by W. M. Englehart and duly seconded by Penn L. Gooldy, that the recommendations of the viewer of the proposed Rock Mountain Highway be accepted and that Carbon County take all necessary measures to lay out, alter and establish said Rocky Mountain Highway as proposed.

Motion unanimously carried.

W. M. Englehart, then moved that the survey of the proposed road by the County surveyor be dispensed with, for the reason that said proposed route had already been surveyed by the State Highway Department and that an additional survey would be unnecessary, the State Highway Department having filed a copy of the plat and the survey notes in the office of the County Clerk, which plat and survey has been duly signed and approved by the County surveyor.

Motion duly seconded by Penn L. Gooldy and carried.

It was then moved by W. M. Englehart that March 23, 1925, at 12 o'clock noon of said day, be set as the date and time on or before which day all objections to the establishment or alteration of the proposed road, and claims for damages therefore must be filed with the County Clerk of Carbon County, Wyoming, at Rawlins, at which time all objections and claims as aforesaid will be heard by said Board.

Motion seconded by Penn L. Gooldy and duly carried.

It was then moved by W. M. Englehart that a notice be published for three successive weeks in three successive issues of the official paper of Carbon County, of the proposed location and alteration of the said Rocky Mountain Highway, the first publication thereof to be made February 3, 1925, which notice shall contain the place of commencement of said road, the description and general terms of its point and courses, the point of termination of the road, and the date and time on or before which objections to proposed road and claims for damages must be filed in writing with the County Clerk.

Motion duly seconded by Penn L. Gooldy and carried.

It was then moved by W. M. Englehart that the County Clerk by registered mail, send a copy of the published notice of the proposed road establishment and alteration to all persons owning lands or claiming any interest in the lands over or across which the proposed road passes.

Motion seconded by P.L. Gooldy and duly carried.

It was duly moved by P.L. Gooldy---seconded by W. M. Englehart and duly carried that the said notice be published in the following form:

NOTICE OF PROPOSED LOCATION, ESTABLISHMENT
AND ALTERATION OF THE ROCKY MOUNTAIN HIGHWAY
BETWEEN SARATOGA AND ENCAMPMENT, CARBON COUNTY, WYOMING.

TO WHOM IT MAY CONCERN: You and each of you are hereby notified that the Board of County Commissioners of Carbon County, Wyoming, has decided to locate, establish, lay out and alter a portion of the road from Encampment to Saratoga, Carbon County, Wyoming, to be known as a part of the Rocky Mountain Highway.

The description of which said proposed road is a parcel of land, eighty (80) feet in width, and being forty (40) feet in either side of, and equidistant from the center line of said road, which commences in Section Five (5), Township Sixteen

(16), North Range Eighty-three (83) West of the 6th P.M., and which terminates in Section Seven (7), Township Fifteen (15), North Range Eighty-three (83), West of the 6th P.M.

The center line of said road is described as follows:

The point of beginning being the point of a 2° curve to the right, the bearing of the tangent being S. 42° 38' E., Thence along said curve through an angle of 16° 28', 823.3 ft. Thence S. 26° 10' E., Paralleling the west right of way line of the Saratoga and Encampment Railroad. 13,682.1 ft. To point of a 15° curve to the right the radius of which is 382 feet. Thence along said curve through an angle of 52° 40', 351.1 ft. Leave railroad. Thence S. 26° 30' W., 6009.8 feet. To point of a 3° curve to the right the radius of which is 1909.9 ft. Thence along said curve through an angle of 9° 25', 313.9 feet. Thence S. 35° 55' W. 998 feet. To point of a 5° curve to the left the radius of which is 1145.9 feet. Thence along said curve through an angle of 15° 30' 00", 300 feet. Thence S. 20° 55' W., 2888.5 ft. To point of a 5° curve to the left the radius of which is 1145.9 feet. Thence along said curve through an angle of 20° 57', 419 ft. Thence S. 0° 02' E. 1077.3 ft. Intersect line between sections 29 and 32 T. 16 N., R. 83 W. Whence the southeast corner of said section 29 bears S. 89° 39' E. 1325.8 ft. Thence S. 0° 02' E., 1196.3 ft. To point of a 4° curve to the right the radius of which is 1432.4 ft. Thence along said curve through an angle of 9° 24' W. 235 feet. Thence S. 9° 22' W. 3895.1 feet. Intersect line between section 32 T. 16 N., R. 83 W. and Section 5 T. 15 N. R 83 W. Whence the south 1/4 corner of said section 32 T. 15 N., R. 83 W. bears N. 89° 07' W. 671.3 ft. Thence S. 9° 22' W., 5292.2 ft. Intersect line between sections 5 and 8 T. 15 N., R. 83 W. Whence the southeast corner of said section 5 bears S. 89° 24' E., 2742.4 feet. Thence S. 9° 22' W., 185.9 feet. To point of a 8° curve to the right the radius of which is 716.2 ft. Thence along said curve through an angle of 32° 37', 407.7 ft. Thence S. 41° 59' W., 1039.6 ft. To point of a 3° curve to the right the radius of which is 1909.9 ft. Thence along said curve through an angle of 9° 43', 323.9 ft. Thence S. 51° 42' W., 1411.7 ft. To point of a 1° curve to the right the radius of which is 5729.7 ft. Thence along said curve through an angle of 2° 32', 253.3 ft. Thence S. 54° 14' W., 111.6 ft. Intersect line between sections 7 and 8 T. 15 N., R. 83 W. Whence the southwest corner of said section 8 bears S. 0° 11' E. 2666.6 ft. Thence S. 54° 14' W., 1103.2 ft. To point of a 10° curve to the left the radius of which is 573 feet. Thence along said curve through an angle of 30° 57', 309.5 ft. Thence S. 23° 17' W. 1841.8 ft. Intersect line between sections 7 and 18 T. 15 N. R. 83 W. Whence the south 1/3 corner of said section 7 bears N. 89° 35' W. 830.7 ft. Thence S. 23° 17' W., 107.3 ft. end of project which is 107.3 feet S. 23° 17' W., of a point which is 830.7 ft. S. 89° 35' E. of the south 1/4 corner of section 7 T. 15 N., R. 83 W.

All persons owning lands or claiming any interest in any lands herein described, over or across which said proposed road will pass, and who have any objections to the location, laying out, establishment or alteration of said proposed road as herein described, or who have any claims or damages for such location, laying out, establishment or alteration of the proposed road, are hereby notified that all such objections or claims for damages must be filed in writing with the County Clerk of Carbon County, Wyoming, at Rawlins, on or before 12 o'clock noon on March 23, 1925, or such objections or claims for damages will be forever barred.




By motion regularly made and carried Mrs. Ridgway of Rawlins was given an allowance of \$12.00 from the poor and pauper fund until further consideration.
