

THE BOARD OF COUNTY COUNTY COMMISSIONERS met this 3rd day of March A.D.1925 at ten o'clock a.m. with all members present and C.W.Morgan presiding.

C.P.Spencer of Cheyenne, attorney, accompanied by Mr.F.E.Richardson of Parco and other officials of the town of Parco, appeared before the board at this with a petition requesting authority to incorporate the above named town. After presenting satisfactory evidence that all preliminary statutory requirements had been complied with, the following resolution offered by W.M.Englehart, seconded by P.L.Gooldy, was duly carried:

O R D E R

The Petition of Frank E.Richardson for the incorporation of the town of Parco, County of Carbon, State of Wyoming, filed in this office February 16th, 1925, having come on this 3rd, day of March, A.D.1925 to be heard before the Board of County Commissioners, County of Carbon, State of Wyoming, requesting that an order be made by this Board appointing three inspectors for the purpose of holding an election of all the qualified electors residing within the territory intended to be incorporated, to determine if the majority of said electors are favorable to the incorporation of the said town as set forth in the aforesaid petition, and said application having been found to meet all the requirements of Chapter 125, Wyoming Compiled Statutes 1920, and all of such requirements having been fully complied with and having ascertained that the territory proposed to be incorporated contains a resident population of not less than one hundred and fifty persons and an area of not more than three square miles.

IT IS ORDERED by this Board upon motion duly made and carried, that such election be held within the territory designated on the 31st day of March A.D.1925, for the purpose of determining if a majority of said electors are favorable to the incorporation of the town of Parco as set forth in the petition of Frank E.Richardson, and the following named qualified electors residing within the said territory are hereby appointed to serve as inspectors to prepare for and to conduct said election in accordance with the requirements of the law;

Motion duly made and carried to recess until Wednesday March 4th at ten o'clock a/m.

Session resumed this 4th, day of March at ten o'clock a.m. with all members present and Mr. Morgan in the chair.

Mr. John Mahoney appeared before the board at this time with a proposition for the settlement of the controversy over the damages sustained by Mr. Mahoney from the Rocky Mountain Highway to his property. His proposal for the appointment of an arbitration board for such purpose was readily agreed to by the Commissioners and arrangements were made for the completion of the necessary details.

Mr. C. H. Fitzpatrick, acting as agent of J. T. Hurst, appeared before the board with an offer to purchase the land formerly owned by the Laramie Valley Cattle Company for the amount of the accrued taxes due Carbon County. On motion by P. L. Gooldy, seconded by W. M. Englehart and duly carried the following resolution was ordered inscribed on the records of this board:

WHEREAS, the said taxes so assessed against said property for the year 1921 amounted to \$1631.82 and said sum remained due and unpaid at the date of sale hereinafter mentioned, and,

WHEREAS, the Treasurer of said County did, on the 29th day of June, 1922, by virtue of authority in him vested by law, sell to Carbon County, Wyoming, the real property above described for the payment of the taxes, interest and costs thereon due and remaining unpaid on said property, and,

WHEREAS, there was assessed against the said property as taxes for the year 1922 the sum of \$1285.44, and for the year 1923, \$1164.84, and for the year 1924, \$1163.18, which sums have not been paid, and,

WHEREAS, J. T. Hurst of Los Angeles, California, has this day offered to pay the sum of \$6680.76, for said property, which sum is equal to the amount for which said property was sold to Carbon County, together with the interest thereon and all taxes assessed against said property since said date, and

WHEREAS, the Board of County Commissioners of Carbon County, Wyoming, have in open meeting considered said bid, and decided that the same was just and fair and equitable for said property.



NOW, THEREFORE, BE IT RESOLVED, that the Board of County Commissioners of Carbon County, Wyoming, does hereby accept said bid and does hereby authorize the Chairman of the said Board of County Commissioners and the Clerk of said Board to execute and deliver to the said J. T. Hurst a proper deed for said property, conveying to him all of the right, title and interest of the said County in and to said property, upon the receipt of said sum of \$6680.76.

CITY PAVING, The position of the County Commissioners having been requested as to their attitude on the question of city paving during the present year, the following letter was drafted and by motion duly made and carried it was ordered that a copy be mailed to the City Clerk:

To the Honorable Mayor and Board of Trustees, City of Rawlins, Wyo.

Gentlemen:

The Board of County Commissioners, taking under consideration the proposition of pavement for the City of Rawlins, wish to state that in their opinion the condition of the taxpayers of this city and county does not at this time justify the additional burden that would be imposed by the installation of pavement in this City until the taxpayers are able to meet the payment of their taxes without additional hardship to themselves.


