In answer to Mr. L. E. Armstrong's appeal in behalf of the Saratoga & Encampment Railroad on motion by W. M. Englehart seconded by P. L. Gooldy and duly carried the following resolution was spread on the minutes of this Board.

WHEREAS, the continued operations of the Saratoga and Encampment Railroad is necessary for the success and well being of the citizens and patrons of the Platte Valley and territory tributary to said road, and

WHEREAS, the future development of large agricultural, lumber, mining and irrigation projects adjacent and tributary to said road depends upon the continued operation of said railroad, and

WHEREAS, the abandonment of said road would materially reduce the present assessed valuation of the taxable property of this county, and

WHEREAS, it is considered for the best interests of the citizens and tax payers of Carbon County that the taxes to be paid and exacted from the owners or lessees for a term of years and until the road is enabled from the traffic furnished to net a reasonable return on a fair valuation of said property, be fixed to the end that whoever operates the road may know what taxes will be required;

It is, therefore, resolved: That for a term of three years, A. D. 1926, 1927, and 1928, the total State, County and City tax shall not exceed Five Hundred Dollars (\$500.00) per year and

That for a term of the following three years, 1929, 1930 and 1931 A. D. the total tax shall not exceed the total sum of Seven Hundred Fifty Dollars (\$750.00) per year.

ELECTION NOTICE.

Notice was received from the City Clerk of Rawlins, Wyoming, that the regular annual municipal election would be held in the City of Rawlins, Wyoming, on the 13th day of April A. D. 1926.

Notice was thereupon given the registration agents of election district embracing Rawlins, to appear at the lawfully designated place of registration the 3rd Tuesday preceding such election, being Tuesday March 23rd, A. D. 1926, and to proceed to register all citizens who appear, claim the right and are qualified to register and who by reason of not being registered, would be disqualified from voting at such election and that such registration agents be required to post notices of the registration of electors in the manner provided by law; and that such agents shall meet for Three (3) consecutive days and then adjourn for one week and shall meet one (1) day for the purpose of revising, correcting and completing such registry list and the registration of such qualified electors who have not heretofore registered.

The clerk of said board was instructed to notify the registry agents to meet at the City Hall on Tuesday, March 23rd, A. D. 1926 and proceed to register as by law required.
