
RESOLUTION S&E RAILROAD

On motion by Frank Schilt seconded by P. L. Gooldy and duly carried the following resolution was spread on the minutes of this Board.

WHEREAS, The County Commissioners of Carbon County on the fourth of March A. D. 1926, by Resolution agreed that the taxes on the Saratoga & Encampment Railroad should not exceed \$500.00 for the years 1926, 1927 and 1928; and that they should not exceed a sum of \$750.00 for the years 1929, 1930 and 1931;

THEREFORE, Be it resolved that this Board concur in the terms of the above Resolution as long as the State and City Taxes shall remain below the above specified amounts for the years above specified; But in event the total State and City Taxes shall exceed the amount indicated for any year then for that year the S&E Railroad shall be required to pay an increased tax in an amount sufficient to cover the increase State and City Taxes.

There being nothing further before the Board at this time the meeting was duly adjourned to meet in regular session on Tuesday October 4th A. D. 1927.
