

SPECIAL SESSION BOARD OF COUNTY COMMISSIONERS

Board met in special session this 21st day of September 1928 with all members present. ROAD

Responding to the advertisement for bids for construction of bridges across the muddy creek and the Platte River the following bids were duly presented.

BRIDGE ACROSS MUDDY CREEK

I., L. J. Dolan of Baggs, Wyoming hereby submit the following proposal to erect a steel span seventy feet long across the Muddy Creek north of Baggs Wyoming, as follows:

To erect said steel for the sum of \$515.50 the county to furnish all material for the bridge and material for a traveler and for the erection of the same. I to use the County Hoist for the erection of the bridge; to drive the Piles for the sum of \$1.50 per foot, I to use the Hoist and Hammer of the County for driving the same; to run the concrete for \$20.00 per yard the County to furnish material for the forms and the cement.

The County to furnish all material and steel for the bridge and to pay by force account for making the necessary repairs to the steel.

BID BY ORA BUNDY

I propose to furnish all necessary labor and all material except that to be furnished by the County and to erect complete and ready for use the seventy foot steel span with wood floor over Muddy Creek near Baggs for the lump sum of \$2984.00.

PLATTE RIVER BRIDGE - By Ora Bundy

I propose to furnish all necessary labor and material except that to be furnished by the County and to erect the bridge over the Platte River near Saratoga, complete and ready for use for the lump sum of \$8840.00 with the understanding that the foundation be not more than five feet below the bed of the river. For the extra depth if required on any piers I will furnish same and place the addition concrete for the actual cost plus 15%.

F. D. Bridges and C. J. Kuhn bid to construct Bridge on Platte River above Saratoga, bridge to have four inch plank floor for the sum of \$3500.00

Bid for setting of eight four foot casings to be filled with concrete concrete to be one part Portland cement and five parts sand and rubble. Casings to go to the depth of five feet unless solid formation is reached or the water making capacity of 200 gal. per minute is reached. Then concrete shall be run. These for the sum of \$4000.00.


On Motion by Mr. Gooldy seconded by F. Schilt and carried the bids on wooden structure over the Platte River near Cow Creek were rejected.

On motion by Pl L. Gooldy duly made and carried it was decided to accept the offer of Ora Bundy for the construction of a steel bridge over Muddy Creek near Baggs for the sum of \$2950.00.
