T. H. Butler of Hanna appeared before the Board at this time and strongly urged construction of a passable winter road connecting Hanna with the Lincoln Highway. The Board assured Co-Operation.

After discussion with Mr. Butler of the dangerous snow conditions obtaining in the district adjacent to the Town of Old Carbon the following resolution was duly passed: WHEREAS, the present route of highway U. S. 30, between Medicine Bow and Ft. Steele In Carbon County, Wyoming, traverses an isolated section of said county peculiarly susceptible to heavy snow fall and drifting during the winter months, resulting in this portion of said highway being closed to use for considerable portions of each winter, and further resulting in death by freezing to one or more travellers each year, and WHEREAS, it appears to said Board a much more feasible route for said highway lies along the north side of, and meanly parallel to, the Union Pacific Railway right-of-way between said points, which route is much less susceptible of snow fall and drifting, and the selection of which route would result in the saving of human life because of its proximity to said railroad, and would further result in the elimination of dangerous railroad crossings at Ft. Steele and Medicine Bow, now, therefore,

BE IT RESOLVED by said Board of County Commissioners, that said Board strongly favors the re-establishment and re-location of said highway along the said proposed route, and

BE IT FURTHER RESOLVED that this resolution be spread at large upon the minutes of the meeting of said Board, and that a copy thereof be submitted to the Wyoming State Highway Department.

A delegation of Stockmen appeared before the Board at this time urging a reduction of the assessed valuation on grazing lands in this County so that it would be comparable

with values on similar lands in other Counties of this State.

Inasmuch as the State Board of Equalization sets the values on these lands, while the Board assured the Stockmen that they would endeavor to get a reduction in these values, they questioned their own ability to obtain the reduction asked for, namely, fifty cents an acre.

The Board thereupon recessed to meet on Wed. February 8th at 10 O'clock A. M.

The Board resumed its session this 8th day of February A. D. 1928 at 10 O'clock A. M. with all Members present; I. K. Miller presiding.

APPRAISERS REPORT

On motion by F. Schilt seconded by P. L. Gooldy and duly carried the following appraisers report covering the appraisement on the Saratoga Ten Mile road was approved:
TO THE COUNTY CLERK OF CARBON COUNTY, WYOMING:

WHEREAS, by motion of the Board of County Commissioners of Carbon County, Wyoming, on January 3rd, 1928, the undersigned, Charles G. Vivion, W. F. Welch and F. R. Richards, as disinterested electors of Carbon County, Wyoming, were duly appointed as appraisers to view and appraise certain portions of the Saratoga-Ten Mile Road proposed to be altered and relocated, said alteration to be made on Sections 33 and 34, Tp. 17 N. of R. 82 W. of the 6th P. M. Carbon County Wyoming; and Sections 3 and 2 in Tp. 16 N. of R. 82 W of the 6th P. M. in said Carbon County, Wyoming.

WHEREAS, the said appointed appraisers were on the 14th day of January, 1928, duly notified in writing by J. E. Buchanan, County Clerk of Carbon County, Wyoming, of the appointment as such appraisers and which said notice, among other things, contained the names of all claimants for damages along the route of said proposed alterations and re-locations, they being hereinafter set forth, the amount of damages claimed by each, the date by which our report of appraisement must be filed, to wit, February 3rd, 1928, and our duties as prescribed by law, and,

WHEREAS, the names of land owners who filed their claims for damages and written objections for the construction of the proposed road are as follows:

1. Geo. F. Breniman.

2. Winthrop Condict.

By virtue of the appointment aforesaid and the said duties prescribed by law incident thereto, as recited in said notice, two of the said appointed appraisers, to wit: F. R. Richards and Charles G. Vivion met at Saratoga, Wyoming, on the 16th day of January, 1928, preparatory to appraising said damages of said claimants; and then and there finding that W. F. Welch would be unable to serve as appraiser, said Charles G. Vivion and F. R. Richards then and there selected and appointed J. W. Larson, a disinterested elector of Carbon County, Wyoming, to serve as appraiser instead of the said W. F. Welch. Thereupon, on the said 16th day of January, 1928, the undersigned appraisers met together in Section 34, Tp. 17 N. of Range 82 W. in said Carbon County, on the line of said proposed re-locations and alterations of said road, and there took and administered to each other an oath to faithfully and impartially discharge our duties as such appraisers, which oaths in writing are hereto annexed, marked Exhibits A, B, and C, and

WHEREAS, we the undersigned appraisers on the 16th day of January, 1928, by virtue of said appointment and by virtue of the law in such case, after duly administering oaths as aforesaid, did proceed along the route of the said proposed relocations and alterations on said road, and viewed the lands of the said claimants herein mentioned and,

WHEREAS, on the 17th day of January, 1928, Charles G. Vivion, one of the said appraisers, in writing notified the said George F. Breniman and Winthrop Condict as claimants that a hearing would be had at Saratoga, Wyoming, on January 26, 1928, at one o'clock P. M., at which hearing the Board of appraisers would hear the testimony and other evidence of said claimants and their witnesses in support of

their claims for damages, and

WHEREAS, said meeting for the purpose of receiving said evidence was held at Saratoga, Wyoming on January 26, 1928, at which time Winthrop Condict and W. C. Condict appeared before said Board, and introduced sworn testimony in support and explanation of the claims of Winthrop Condict,

NOW THEREFORE, we the said appraisers do hereby appraise and fix the amount of damages sustained by each claimant as hereinafter set forth, and do reject the claims for damages as recited in our said notice of appointment;
