PLATTE RIVER BRIDGE AT MCKEE RANCH

Supporting the requests of citizens of the Platte Valley for a bridge at the McKee Ranch across the Platte river it was regularly moved and seconded that the following resolution be adopted:

WHEREAS, a bridge across the Platte River at or near the South end of the McKee ranch is of vital interest to the citizens of Platte Valley, and especially to the citizens of the East side of the Platte River; and

WHEREAS, it has been agreed that the citizens of said vicinity will furnish the structural timber for said bridge; and

WHEREAS, W. C. Condict does agree to give an Eighty (80) foot right of way for a road through his land connecting this bridge with the Snowy Range road at Buffalo Gulch, as per his letter addressed to the Board of even date herewith,

NOW, THEREFORE, we do hereby authorize the building of this bridge during the Season of the year 1928, and to construct a road from said bridge to the present Brush Creek Post Road, running about approximately

a mile and a half East of the said bridge site.

The proposals made by W. C. Condict and Winthrop Condict are as follows, which were duly accepted:

Gentlemen:

Whereas the bridge across the North Platte River at or about the South end of the McKee ranch is of vital interest to the citizens and tax-payers of the Platte Valley and especially to the people on the East side of the Platte River, I hereby agree that if the County Commissioners will build the said bridge during the year 1928, the citizens of this vicinity will furnish the structural timbers for a three span bridge of approximately sixty (60) feet per span, laid down at the bridge site.

I further agree to give an eighty (80) foot right of way across my land for a road connecting this bridge with the Snowy Range highway at Buffalo Gulch; said right of way to pass up Elk Hollow Creek along the north side of my land, through the North draw, which is in the north portion of my ranch, which is along the lines as viewed by the County Commissioners with me, during the summer of 1927.

Gentlemen:

Whereas the building of a bridge is contemplated across the Platte River at or near the South end of the McKee ranch, I hereby agree to give my half of an eighty (80) foot right of way along the South end of my land, known as the Edwin E. Ryan ranch, which is a part of the land connecting this bridge with the Brush Creek post road.


COMMISSIONERS' DEED

STREET PAVEMENT ABUTTING COUNTY PROPERTY.


