#### MEDICINE BOW - CASPER HIGHWAY

By motion duly made and carried the following Resolution was ordered spread on the minutes:

WHEREAS, it appears necessary for the welfare and convenience of the people of Carbon County, Wyoming, that the present Casper-Medicine Bow road be completed to the North line of Carbon County, through the Little Medicine Settlement, a distance of approximately twenty-four miles, to connect up with present construction in Natrona County, and WHEREAS, it appears that it would be more economical for Carbon County to employ the Natrona County construction crew and outfit to complete this portion of said road in connection with the Natrona County operations at present being carried on adjacent to the County line, now, therefore,

BE IT RESOLVED by the Board of County Commissioners of Carbon County, Wyoming, in regular session sitting, at the regular May, 1928, meeting of said Board, that the road crew and outfit of Natrona County be employed to complete said portion of said road in Carbon County, at the agreed rate of Fifty Dollars per day, said road construction to be done in a workmanlike manner and agreeable to good engineering practices, and in accordance with the practices employed in the construction of the remaining portions of said road; said construction to be along the survey established

by the County Surveyor of Carbon County.

Done at Rawlins, Wyoming, this 2 day of May, 1928.

The Board thereupon recessed to meet at 10 O'clock A. M. on the 2nd day of May A. D. 1928.

On motion made and duly carried it was decided to advertise for condemnation the following proposed Medicine Bow - Casper highway.

Beginning at a point in the southwest quarter of Section 9, T. 25 N., R. 78 W., on the present road between Medicine Bow and Shirley.

Thence running in a northeasterly and northerly direction through Section 9, the NW $\frac{1}{4}$  NW $\frac{1}{4}$  of Section 10, and Section 3, T. 25 N., R. 78 W.; Sections 34, 27, 26, 23, 14, 11, 12, and 1, T. 26 N., R. 78 W.; Section 6 T. 26 N., R. 77 W.; Section 31, 30, 19, 20, 17, 8 and 5, T. 27 N., R. 77 W.; Sections 32, 29, 30, 19, 18, 7, 6, and 5, T. 28 N., R. 77 W., terminating at a point on the line between Carbon and Natrona Counties, located east 270 feet from the northwest corner of Section 5, T. 28 N., R. 77 W.

#### DEPUTY SHERIFF


On motion made and carried Otto Plaga was approved as Deputy Sheriff in the Place of Sam Kuykendall, resigned.
