

D. 1928 for the purpose of voting on the nominations of the following officers, to-wit:

BOARD OF COUNTY COMMISSIONERS--SPECIAL SESSION

July 6th, A. D. 1928

ELECTION DISTRICTS.

In compliance with the Wyoming Compiled Statutes of 1920 and subsequent session laws the Board established Election Districts as follows: also Election Precincts in the several Election Districts to-wit:

DISTRICT NO. 1, RAWLINS.

All that territory embraced within the following boundaries shall be known as Election District No. 1.

Beginning at the Northeast corner of Township 24 N. R. 86 W; running thence west along the township line between Townships 24 and 25 to the northwest corner of Township 24 N. R. 89W.; thence south along the west boundary line of Carbon County to the southwest corner of Township 20 N. R. 89 W. thence west on the township line between townships 19 and 20 to the range line between ranges 90 and 91; thence south on the range line between 90 and 91; thence south on the range line between Ranges 90 and 91 to the southwest corner of Township 16 N. R. 90 W.; thence east on the Township line between townships 15 and 16 to the line between ranges 87 and 88 W.; thence north on the range line between ranges 87 and 88 to the southwest corner of Township 18 N. R. 87 W.; thence east on the Township line between townships 17 and 18 to the southeast corner of Twp. 18, N. R. 86 W.; thence north on Range line between ranges 85 and 86 to the Township line between Townships 18 and 19; thence east on said Township line to the range line between ranges 84 and 85; thence north on Range line between Ranges 84 and 85 to the Township line between Township 19 and 20; thence West on the Township line between Townships 19 and 20 to the range line between Ranges 85 and 86; thence north on the range line between Ranges 85 and 86 to the northeast corner of Township 24, N. R. 86 W. the place of beginning, except and ommitting Township 21, N. Range 86, W. 6th P. M.

DISTRICT NO. 4, WHISKEY GAP.

All that territory embraced within the following boundaries shall be known as Election District No. 4.

Beginning at the southwest corner of Township 25, N. R. 89 W.; thence east on a line between Townships 24 and 25 to the North Platte River; thence northwesterly along the North Platte River to the line between Section 18 and 19, Township 27 N. R. 84 W.; thence west along the line between sections 18 and 19, Township 27, N. Range 84 W. to the line between Range 84 and 85; thence north along the line between Ranges 84 and 85 to the North line of Carbon County; thence west along the line between Carbon and Natrona Counties to the line between Carbon and Fremont Counties; thence south along the west line of Carbon County, to the place of beginning.

DISTRICT NO. 5, FORT STEELE

All that territory embraced within the following boundaries shall be known as Election District No. 5.

Beginning at the Southeast corner of Township 20, on a line between Ranges 84 and 85; thence north on said line between Ranges 84 and 85 to the line between Townships 24 and 25; thence west along said line between Townships 24 and 25 to the line between Ranges 85 and 86; thence south along said line between Ranges 85 and 86 to the line between Townships 19 and 20, thence east along said line to the place of beginning.

DISTRICT NO. 6, LEO

All that territory embraced within the following boundaries shall be known as Election District No. 6.

Beginning at the southeast corner of Township 24 N. R. 80 W. thence north on Range line between Ranges 79 and 80 to the Northeast corner of Township 25 N. Range 80 W thence west on Township line between Townships 25 and 26 to the northwest corner of Township 25, N. Range 80 W. 6th P. M.; thence north along the line between Ranges 80 and 81 to the north line of Carbon County; thence west along the north line of Carbon County to the line between Ranges 84 and 85 W.; thence south to the line between Sections 18 and 19 in Township 27, N. R. 84 W.; thence east along the line between sections 18 and 19 Township 27 N. Range 84 W. to the North Platte River; thence southeasterly along the line between Townships 24 and 25 to the northwest corner of Township 24 N. R. 83 W. thence south to the southwest corner of Township 24 N. Range 83 W.; thence east along the line between Townships 23 and 24 to the place of beginning.

DISTRICT NO. 7, MEDICINE BOW.

All that territory embraced within the following boundaries shall be known as Election District No. 7.

All of Townships 26 and 27 and 28 N. R. 80, all of Townships 22, 23, 24, 25, 26, 27, and 28, Ranges 78 and 79 and all that portion of Townships 22, 23, 24, 25, 26, 27, and 28, N. R. 77 W., which lies in Carbon County, Wyoming, shall be known as Election District No. 7.

DISTRICT NO. 8, HANNA

All that territory embraced within Townships 21, 22, and 23, N. Range 81, 82 and 83 W. and also all of Townships 22 and 23 in Range 80, shall be known as Election District No. 8.

DISTRICT NO. 9, ELK MOUNTAIN

All that territory embraced within Townships 20 and 21 in Range 78, 79, and 80 and that portion of Townships 20 and 21 N. R. 77 W. of the 6th P. M., which lies in Carbon County, Wyoming, shall be known as Election District No. 9.

DISTRICT NO. 10 ROCKDALE

All that territory embraced within Township 18 N. R. 81 all of Townships 18 and 19, N. Ranges 78 and 79, and all that portion of Townships 17, 18 and 19 N. Range, 77 W. of the 6th P. M., which lies in Carbon County, Wyoming, shall be known as Election District No. 10.

DISTRICT NO. 11, GREEN

All that territory embraced within townships 19 and 20 N. Ranges 81, 82 and 83 W of the 6th P. M., shall be known as Election District No. 11.

DISTRICT NO. 12, SARATOGA.

All that territory embraced within the following boundaries shall be known as Election District No. 12.

Beginning at the southeast corner of Section 1, Township 16, N. R. 82 W. of the 6th P. M., thence north on the Range line between Ranges 81 and 82 to the Township line between Townships 18 and 19, thence west on the Township line between Townships 18 and 19 to the Range line between Ranges 85 and 86, thence south on the range line between Ranges 85 and 86 to the Township line between Townships 17 and 18, thence west on the Township line between Townships 17 and 18 to the Range line between Ranges 87 and 88; thence south on the Range line between Ranges 87 and 88 to the Township line

between Townships 16 and 17; thence east on the Township line between Townships 16 and 17 to the northeast corner of Township 16, N. R. 84 W. thence south on the range line between ranges 83 and 84 to the southeast corner of Section 1, Township 16, N. R. 84 W. 6th P. M., thence due east to the southeast corner of Section 1, Township 16, N. R. 82 W. of the 6th P. M., the place of beginning.

DISTRICT NO. 13, RIVERSIDE

All that territory embraced within the following boundaries, together with that territory embraced within the Town of Riverside, Carbon County, Wyoming; shall be known as election District No. 13.

Beginning at the northeast corner of Section 12, Township 16, N. Range 83 W. of the 6th P. M., running thence due west to the ~~southeast~~ corner of Section 1, Township 16 N. R. 84 W.; thence north on Range line between Ranges 83 and 84 to the Township line between Townships 16 and 17; thence west on Township line between Townships 16 and 17 to the Range line between Ranges 85 and 86,; thence south on Range line between Ranges 85 and 86 to the Township line between Townships 15 and 14; thence east on the Township line between Townships 14 and 15 to the Range line between Ranges 82 and 83; thence north on the Range line between Ranges 82 and 83 to the northeast corner of Section 12, Township 16, N. Range 83 West. of the 6th P. M., the place of beginning, also including all that territory embraced with the corporate limits of the Town of Riverside, Carbon County, Wyoming.

DISTRICT NO. 14, BENNETT

All that territory embraced within townships 15 and 16 and 17 in Ranges 80 and 81, all of Township 15 N. Range 82 and all of Township 16 N. Range 82 W. of the 6th P. M., save and except all of Sections 1, 2, 3, 4, 5, and 6, in Township 16, N. R. 82 W. of the 6th P. M., shall be known as Election District No. 14.

DISTRICT NO. 15, ENCAMPMENT

All that territory embraced within Township 13 and 14, N. Range 80, 81, 82, 83, 84, and 85, all that portion of Township 12, N. Ranges 80, 81, 82, 83, 84 and 85 which lies in Carbon County, Wyoming, and all of Township 14, N. R. 86 W. of the 6th P. M., shall be known as Election District No. 15, save and except that portion which lies within the corporate limits of the Town of Riverside, Carbon County, Wyoming.

DISTRICT NO. 16, SNAKE RIVER.

All that territory embraced within the following boundaries shall be known as Election District No. 16,

Beginning at the northeast corner of Township 16, N. R. 86 W running thence west on the Township line between Townships 16 and 17 to the Range line between Ranges 87 and 88 W. thence south on the range line between Ranges 87 and 88 to the Township line between Townships 15 and 16; thence west on the Township line between Townships 15 and 16, to the west line of Carbon County, Wyoming; running thence south on the west line of Carbon County, Wyoming, to the line between Colorado and Wyoming, thence east on the Colorado State Line to the Range line between Ranges 85 and 86; thence north on the range line between Ranges 85 and 86 to the Township line between Townships 13 and 14; thence west on the Township line between Townships 13 and 14 to the Range line between Ranges 86 and 87; thence north on the Range line between Ranges 86 and 87 to the Township line between Townships 14 and 15; thence east on the Township line be-

tween Townships 14 and 15 to the Range line between Ranges 85 and 86; thence north on the Range line between Ranges 85 and 86 to the northeast corner of Township 16, N. R. 86 W. of the 6th P. M. the place of beginning.

DISTRICT NO. 17, DAD

All that Territory embraced within Townships 16, 17, 18 and 19 N. R. 91, 92 and 93 W of the 6th P. M., shall be known as Election District No. 17.

DISTRICT NO. 18, WALCOTT

All that territory embraced within Townships 19, 20, 21, 22, 23 and 24, N. R. 84 W. of the 6th P. M., shall be known as Election District No. 18.

DISTRICT NO. 19, PARCO

All that territory embraced within Township 21, N. R. 86 W. 6th P. M., shall be known as Election District No. 19.

ELECTION PRECINCTS.

Election District No. 1 shall consist of four election precincts.

RAWLINS PRECINCT NO. 1, shall consist of all that portion of the City of Rawlins, lying south of Lincoln Highway Street and East of Eighth (8th) Street, in the City of Rawlins, and everything south of the Railroad Track, and also all that territory outside of the corporate limits of said City of Rawlins in said Section District No. 1, excepting and omitting all Territory embraced within Township 21, N. R. 86 W. 6th P. M.

RAWLINS PRECINCT NO. 2, shall consist of all that portion of the city of Rawlins, lying South of Walnut Street, West of Fourth (4th) Street North of Lincoln Highway Street and East of Eighth (8th) Street, including also the State Penitentiary grounds.

RAWLINS PRECINCT NO. 3, shall consist of everything North of Lincoln Highway and East of Fourth (4th) Street in said City of Rawlins, also all that territory outside of the corporate limits of said City of Rawlins, lying north of the Union Pacific Railroad Track in said Election district No. 1, excepting and omitting all Territory embraced within Township 21, N. R. 86 W. 6th P. M.

RAWLINS PRECINCT NO. 4, shall consist of all that portion of the City of Rawlins lying West of the State Penitentiary Grounds and West of Eighth (8th) Street to the Union Pacific Railroad Tracks, also all that territory outside of the corporate limits of said City of Rawlins, lying north of the Union Pacific Railroad Track in said Election District No. 1, excepting and omitting all Territory embraced within Township 21, N. R. 86 W. 6th P. M.

ELECTION DISTRICT NO. 4, shall consist of Two Election precincts.

LAMONT PRECINCT NO. 1, shall consist of all of that part of Election District No. 4 described as follows: Townships No. 26, 27, and 28 Range 89 and also Townships No. 26, 27, 28, Range 88 and Township 28, R. 87 W. of 6th P. M.

P. & R. MARVIN PRECINCT NO. 2, shall consist of all of that part of District No. 4 east of Precinct No. 1, and not embraced therein.

ELECTION DISTRICT NO. 5, shall consist of one election precinct.

FORT STEELE PRECINCT NO. 1, shall consist of all that territory embraced within Election District No. 5.

ELECTION DISTRICT NO. 6, shall consist of five election precincts.

LEO PRECINCT NO. 1, shall consist of all that territory embraced within townships

24, Ranges 82 and 83 and all of Townships 24, Range 82 and 83 and all that portion of Range 84 lying east of the North Platte River in Township 25.

SHIRLEY PRECINCT NO. 2 shall consist of all that territory embraced within township 26, Range 81 and Townships 27 and 28 in Ranges 81 and 82 W.

COWDIN PRECINCT NO. 3, shall consist of all the territory embraced within Townships 26, Range 82, and all of Township 26 in Range 83 and that part of Township 26, Range 84 W., lying east of the North Platte River.

PEDRO PRECINCT NO. 4, shall consist of all that territory embraced in Townships 27 and 28 in Ranges 83 and 84, except that part of Township 27 and Range 84 W. lying west of the North Platte River.

DIFFICULTY PRECINCT NO. 5, shall consist of all that territory embraced within Townships 24 and 25, Ranges 80 and 81 W. of the 6th P. M.,

ELECTION DISTRICT NO. 7, shall consist of one election precinct.

MEDICINE BOW PRECINCT NO. 1, shall consist of all that territory embraced within Election District No. 7.

ELECTION DISTRICT NO. 8, shall consist of Two election precincts.

HANNA PRECINCT NO. 1, shall consist of all that territory embraced within said Election District No. 8, except Sections 15, 16, 21 and 22, in Township 22, N. R. 81 W. 6th P. M.

ELMO PRECINCT NO. 2, shall consist of all that territory embraced within Sections 15 and 16, 21, and 22, in Township 22, N. R. 81, W. of the 6th P. M.

ELECTION DISTRICT NO. 9, shall consist of one election precinct.

ELK MOUNTAIN PRECINCT NO. 1, shall consist of all that territory embraced within Election district No. 9.

ELECTION DISTRICT NO. 10, shall consist of three election precincts.

McFADDEN PRECINCT NO. 1, shall consist of all that territory embraced within Townships 19, Ranges 77, 78 and 79, in said Election District No. 10.

MORGAN PRECINCT NO. 2, shall consist of all that territory embraced within Townships 17 and 18, Ranges 77, 78 and 79 in said Election District No. 10.

WIDOWFIELD PRECINCT NO. 3, shall consist of all that territory embraced within Townships 18 and 19, Range 80, and Township 18, N. R. 81, in said Election District No. 10.

ELECTION DISTRICT NO. 11, shall consist of one election precinct.

GREEN PRECINCT. NO. 1, shall consist of all that territory embraced within election District No. 11.

ELECTION DISTRICT NO. 12, shall consist of one election precinct.

SARATOGA PRECINCT NO. 1, shall consist of all that territory embraced within election District No. 12.

ELECTION DISTRICT NO. 13, shall consist of three election precincts.

COW CREEK PRECINCT NO. 1, shall consist of all that territory within said Election District No. 13, divided by Cow Creek and Calf Creek, except that divided by Calf Creek.

SPRING CREEK PRECINCT NO. 2, shall consist of all that territory embraced within said Election District No. 13, divided by Spring Creek and Calf Creek, except that part embraced within Riverside Precinct. No. 3.

RIVERSIDE PRECINCT NO. 3, shall consist of all that territory embraced within Township 15, N. R. 83 W. and also the Town of Riverside in Section 1, Township 14, N. R. 84 W., except Section 5, 6 and 7 in Township 15, N. Range 83 W.

ELECTION DISTRICT NO. 14, shall consist of two election precincts.

BENNETT PRECINCT NO. 1, shall consist of all that territory embraced within the West Half of Township 15, N. R. 82 W. all of Township 16, N. R. 82 W. except Sections 1, 2, 3, 4, 5, and 6, in said Township also all of Townships 16 and 17, N. Ranges 80 and 81 W.

FRENCH PRECINCT NO. 2, shall consist of all that territory embraced within the East half of Township 15, N. R. 82 W. and all of Township 15 N. R. 80 W. and 81 W. in election District No. 14.

ELECTION DISTRICT NO. 15, shall consist of three election precincts.

COLLINS PRECINCT NO. 1, shall consist of all that territory embraced within Townships 12, 13 and 14 in Ranges 82 and 83 W.

ENCAMPMENT PRECINCT NO. 2, shall consist of all that territory embraced within Township 14, N. R. 86 W. also all of Townships 12, 13, and 14, in Ranges 84 and 85 in said Election District No. 15, save and except that certain territory contained in Riverside Precinct.

BIG CREEK PRECINCT NO. 3, shall consist of all that territory embraced within all that portion of Election District No. 15, in Township 12, 13 and 14, Ranges 80 and 81 W.

ELECTION DISTRICT NO. 16, shall consist of five election precincts.

SAVERY PRECINCT NO. 1, shall consist of all that territory embraced within said Election District No. 16, in Townships 12, 13, 14, 15, and 16, in Ranges 86, 87, 88 and 89, except that portion embraced within the precinct of Brown's Hill No. 5.

DIXON PRECINCT NO. 2, shall consist of all that territory embraced within Townships 12, 13, 14 and 15, Range 90 W. in said Election District No. 16, save and except Sections 1, 2, 11, 12, 13, 14, 23, 24, 25, 35, and 36 in Townships 14 and 15, Range 90 W.

BAGGS PRECINCT NO. 3, shall consist of all that territory embraced within Townships 12, 13, 14, and 15 Ranges 91 and 92 W. in said Election District No. 16.

SAND CREEK PRECINCT NO. 4, shall consist of all that territory embraced within Election District No. 16, in Townships 12, 13, 14, and 15 Ranges 93 W of the 6th P. M.

BROWN'S HILL PRECINCT NO. 5. shall consist of all that territory embraced within Township 15, Ranges 88 and 89 also all of Sections 1, 2, 11, 12, 13, 14, 23, 24, 25, 26 35, and 36 in Townships 14 and 15, Range 90 W. and all of Township 14 N. R. 89 W. excepting Sections 1, 12, 13, 24, 25, and 36, in Township 14, N. R. 89 W.

ELECTION DISTRICT NO. 17, shall consist of one election precinct.

DAD PRECINCT NO. 1, shall consist of all that territory embraced within Election District No. 17.

ELECTION DISTRICT NO. 18, shall consist of one election precinct.

WALCOTT PRECINCT NO. 1, shall consist of all that territory embraced within Election District No. 16.

ELECTION DISTRICT NO. 19, shall consist of one election precinct.

PARCO PRECINCT NO. 1, shall consist of all that territory embraced within Election District No. 19.
