RESOLUTION

"On motion of Commissioner Schilt seconded by Commissioner Ellis, the following resolution was adopted by the unanimous vote of the members of the Board:

Whereas under the provisions of Section 9 of Chapter 129 of the Wyoming Session Laws of 1927, this Board is authorized and required to make a levy of one-twentieth (1/20) of a mill on all taxable property for the credit of the Department of Commerce and Industry:

Now Therefore Be It Resolved that, for the purpose of complying with said statutory requirement and purpose, there is hereby levied upon all taxable property within the County of Carbon, for the year 1929, one-twentieth of one mill (.05mill), the money collected by reason of said levy to be paid by the County Treasurer to the State Treasurer as by said statute provided."

RESOLUTION

At the request of the County Treasurer the following resolution was moved, seconded and carried:

Whereas, the County Treasurer's records show \$1605.66 as deposited to the credit of Carbon County in the defunct Stock Growers State Bank of Dixon, and

Whereas, the Receivership with said Stock Growers State Bank of Dixon, has been closed, the Board of County Commissioners hereby authorizes the County Treasurer of Carbon County to charge off the amount of \$1605.66 as an uncollectable asset.

TAX LEVY

D. including the valuation of property of Railroad, Car, Telegraph and Telephone Companies as assessed to them by the State Board of Equalization."


