HIGHWAY APPRAISERS REPORT

We, the appraisers duly appointed to make a report of our appraisement of damages sustained by land owners in the above matter, hereby report and certify as follows:

That on the 4th day of February, 1929, we met together at a point on said proposed re-location of said road, on the land of the Savage Livestock Company, and then and there administered to each other the oath required by law, conditioned for the faithful performance of our respective duties as such appraisers.


