By motion duly made and carried the Board approved the contract between the Union Pacific Railroad Co., the State Highway Department and the County of Carbon for the building and maintenance of a viaduct over the Union Pacific Railroad east of the Town of Parco.

M. near Walcott, Wyo. and on motion by Chas. Ellis which was duly carried the following resolution was adopted;

WHEREAS, THE STATE HIGHWAY DEPARTMENT has requested the County of Carbon to secure a new right of way for the Lincoln Highway between the east boundary of the town of Parco and a point on the Lincoln Highway in section 35, township 21, range 84 W. of 6th P. M.,

and WHEREAS, the Board considers the best interests of the county will be conserved by the construction of this piece of road this present season, therefor be it

RESOLVED that this board awards as damages to claimants affected by the construction of said highway as follows:

On motion duly made and carried the County Clerk was ordered to prepare a commissioners deed for I. M. Conness for the following described County property.


