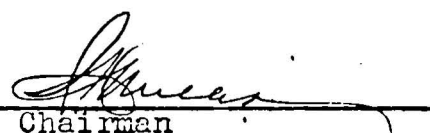
By motion made and carried Mrs. A. J. Rosier was appointed to succeed herself as Trustee of Carbon County Library.
