

#### ELECTION DISTRICTS

##### DISTRICT NO. ONE

Beginning at a point on Section line between Section 19 and 20 and proceeding in a Northeast direction paralleling the Railroad to the Junction of seventh street and front street, thence running north on seventh street to Buffalo Street, thence northeast on Buffalo Street to section line between Section 15 and 16, thence south to section line between section 21 and 28, thence west to Southwest corner of Section 20, thence north to point of beginning all in Township 21 Range 87.

##### DISTRICT NO. TWO

Beginning at intersection of Seventh Street and Buffalo Street, thence along Buffalo Street in Northeast direction to Section line between Sections 15 and 16, thence North to the Northeast corner of Section 16, thence West to a point on the Section lines between Section 8 and 17, thence South on Seventh Street to point of beginning all in Township 21 Range 87.

And beginning at the Northeast corner of Township 24 North Range 86 West running thence west along the Township line between Townships 24 and 25 to the Northwest corner of Township 24 North Range 89 West; thence south along the west boundary line of Carbon County to the Southwest corner of Township 20 North Range 89 West, thence west on the Township line between Townships 19 and 20 to the range line between Ranges 90 and 91.

thence South on the Range line between 90 and 91 to the Southwest corner of Township 16 North Range 90 West; thence East on the Township line between Townships 15 and 16 to the line between Ranges 87 and 88 West; thence North on the Range line between Ranges 87 and 88 to the Southwest corner of Township 18 North Range 87 West; thence East on the Township line between Townships 17 and 18 to the Southeast corner of Township 18 North Range 86 West; thence North on the Range line between Ranges 85 and 86 to the Township line between Townships 18 and 19; thence East on said Township line to the Range line between Ranges 84 and 85; thence North on Range line between Ranges 84 and 85 to the Township line between Townships 19 and 20; thence West on the Township line between Townships 19 and 20 to the Range line between Range 85 and 86; thence North on the Range line between Ranges 85 and 86 to the Northeast corner of Township 24 North Range 86 West the place of beginning except and omitting Township 21 North Range 86 West 6th P. M. which is the election District of Parco, also the area included in election district No. 1 and No. 3.

#### DISTRICT NO. 3

Beginning at a point on Section line between Sections 19 and 20 running on a line in an easterly direction to the intersection of Seventh and Front Streets; thence North on seventh street to a point on section line between Section 8 and 17; thence West to the Northwest corner of Section 17; thence South on Section line to point of beginning.

#### PRECINCTS

Precinct No 1 District No. 1

All area in District No. 1 lying South of Railroad Tracks

#### Precinct No. 2 District No. 1

All of District No. 1 lying North of Railroad Tracks

#### Precinct No. 1 District No. 2

Beginning at intersection of Second and Buffalo Streets thence east on Buffalo Street to a point on section line between Sections 15 and 16; thence North to Northeast corner of Section 16; thence west to a point between Sections 8 and 17; thence South on Second street to a point of beginning.

#### Precinct No. 2 District No. 2

Beginning at a point on Section line between Sections 8 and 17 running South on Seventh Street to Buffalo Street; thence East on Buffalo Street to Second Street thence North on Second street to Section line between Section 8 and 17 and all the rest of the District 2 lying outside the corporate limits of Rawlins.

All voters of Election District Number 2 outside of the corporate limits of the City of Rawlins, shall vote in Precinct Number 2.

#### Precinct No. 1 District No. 3

Beginning at the West end of Lincoln Highway running East on the Lincoln Highway to Tenth Street; thence north on Tenth Street to the alley between Walnut Street and Maple Street; thence east to the Lot line between Lots Nos. 3 and 4 Block 54, U. P. 5th Addition to Rawlins; thence north to Walnut Street; thence east to Seventh Street; thence South to Front Street; thence west to point of Section Line between Sections 19 and 20; thence north to point of beginning.

#### Precinct No. 2 District No. 3

Beginning in the West on Lincoln Highway thence east to Tenth Street; thence north to the alley between Walnut and Maple Streets; thence east to the Lot Line between Lots 3 and 4 Block 54, U. P. 5th Addition to Rawlins; thence north to Walnut Street; thence

thence east to seventh Street; thence north to point on section line between Section 8 and 17; thence west to northwest corner of Section 17; thence south to point of beginning.

DISTRICT NO. 4, WHISKEY GAP.

All that territory embraced within the following boundaries shall be known as Election District No. 4.

Beginning at the southwest corner of Township 25, N. R. 89 W.; thence east on a line between Townships 24 and 25 to the North Platte River; thence northwesterly along the North Platte River to the line between Section 18 and 19, Township 27 N. R. 84 W.; thence west along the line between sections 18 and 19; Township 27 N. Range 84 W. to the line between Range 84 and 85; thence north along the line between Ranges 84 and 85 to the North line of Carbon County; thence west along the line between Carbon and Natrona Counties to the line between Carbon and Fremont Counties; thence south along the west line of Carbon County, to the place of beginning.

DISTRICT NO. 5, FORT STEELE

All that territory embraced within the following boundaries shall be known as Election District No. 5.

Beginning at the southeast corner of Township 20, on a line between Ranges 84 and 85; thence north on said line between Ranges 84 and 85 to the line between Townships 24 and 25; thence west along said line between Townships 24 and 25 to the line between Ranges 85 and 86; thence south along said line between Ranges 85 and 86 to the line between Townships 19 and 20, thence east along said line to the place of beginning.

DISTRICT NO. 6 LEO

All that territory embraced within the following boundaries shall be known as Election District No. 6.

Beginning at the southeast corner of Township 24 N. R. 80 W. thence north on Range line between Ranges 79 and 80 to the Northeast corner of Township 25 N. Range 80 W. thence west on Township line between Townships 25 and 26 to the northwest corner of Township 25, N. Range 80 W. 6th P. M.; thence north along the line between Ranges 80 and 81 to the north line of Carbon County; thence west along the north line of Carbon County to the line between Ranges 84 and 85 W.; thence south to the line between Sections 18 and 19 in Township 27, N. R. 84 W.; thence east along the line between section 18 and 19 Township 27 N. Range 84 W. to the North Platte River; thence southeasterly along the line between Townships 24 and 25 to the northwest corner of Township 24 N. R. 83 W. thence south to the southwest corner of Township 24 N. Range 83 W.; thence east along the line between Townships 23 and 24 to the place of beginning except that Township 28 of Range 80 shall be withdrawn from the above description and added to District No. 7 and Township 24 Range 81 shall be withdrawn from the above described district No. 6 and added to District No. 8.

DISTRICT NO. 7, MEDICINE BOW.

Township 24 Range 80 and all that territory embraced within the following boundaries shall be known as Election District No. 7.

All of Townships 26 and 27 and 28 N. R. 80, All of Townships 22, 23, 24, 25, 26, 27 and 28, Ranges 78 and 79 and all that portion of Townships 22, 23, 24, 25, 26, 27, and 28, N. R. 77 W., which lies in Carbon County, Wyoming shall be known as Election District No. 7.

DISTRICT NO. 8, HANNA

Township 24 N. Range 81 and all that territory embraced within Townships 21, 22, and 23 N. Range 81 82 and 83 W. and also all of Townships 22 and 23 in Range 80, shall be known as Election District No. 8.

DISTRICT NO. 9, ELK MOUNTAIN

Township 18 Range 81 and Township 18 , 19 Range 80 and all that territory embraced within Townships 20 and 21 in Range 78, 79, and 80 and that portion of Townships 20 and 21 N. R. 77 W. of the 6th P. M., which lies in Carbon County, Wyoming, shall be known as Election District No. 9.

DISTRICT NO. 10, ROCKDALE

All that territory embraced within Township 18 N. R. 81 all of Township 18 and 19, N. Ranges 78 and 79, and all that portion of Townships 17, 18 and 19 N. Range 77 W of the 6th P. M., which lies in Carbon County, Wyoming shall be known as Election District No. 10, except Township 18 Range 81 and Township 18 and 19 Range 80 are withdrawn and added to District No. 9

DISTRICT NO. 11, SARATOGA

All that territory embraced within townships 19 and 20 N. Range 81 82 and 83 W of the 6th P. M. and beginning at the woutheast corner of Section 1, Township 16, N. R. 82 W. of the 6th P. M., thence north on the Range line between Ranges 81 and 82 to the Township line between Townships 18 and 19, thence west on the Township line between Townships 18 and 19 to the Range line between Ranges 85 and 86, thence south on the range line between Ranges 85 and 86 to the Township line between Townships 17 and 18 thence west on the Township line between Townships 17 and 18 to the Range line between Ranges 87 and 88; thence south on the Range line between Ranges 87 and 88 to the Township line between Townships 16 and 17; thence east on the Township line between Townships 16 and 17 to the northeast corner of Township 16, N. R. 84 W. thence south on the range line between ranges 83 and 84 to the southeast corner of Section 1 Township 16, N. R. 84 W. 6th P. M., thence due east to the southeast corner of Section 1, Township 16, N. R. 82 W. of the 6th P . M., the place of beginning.

DISTRICT NO. 12 RIVERSIDE

All that territory embraced within the following boundaries, together with that territory embraced within the Town of Riverside, Carbon County, Wyoming; shall be known as election District No. 12.

Beginning at the northeast corner of Section 12, Township 16, N. Range 83 W. of the 6th P. M., running thence due west to the southeast corner of Section 1, Township 16 N. R. 84 W.; thence north on Range line between Ranges 83 and 84 to the Township line between Townships 16 and 17; thence west on Township line between Townships 16 and 17 to the Range line between Ranges 85 and 86; thence south on Range line between Ranges 85 and 86 to the Township line between Townships 15 and 14; thence east on the Township line between Townships 14 and 15 to the Range line between Ranges 82 and 83; thence north on the Range line between Ranges 82 and 83 to the northeast corner of Section 12, Township 16, N.
