By motion made and carried James Horne of Medicine Bow, C. H. Sanger of French and I. J. Rendle of Rawlins were appointed as a Board to appraise the damage done to land owners by the establishment of the aforementioned stock driveway.

At this time County Commissioner Charles Ellis introduced the following resolution and moved its adoption:

RESOLUTION

Whereas the rental and repair of tents for use of the County Fair Board in providing space for exhibits at the last Carbon County Fair resulted in an expenditure of over Seventeen Hundred Dollars, and

Whereas, there is good reason to believe a similar or larger expenditure annually may be anticipated in conducting the annual Carbon County Fair, and

Whereas, the annual expenditure aforesaid for tents for housing exhibits will more than offset the cost of a suitable building or buildings for exhibition purposes in connection with said annual fair, and

Whereas the tents obtainable are not sufficiently substantial to withstand the wind and weather of this section, and the lives of spectators have been endangered by the collapse and threatened collapse of said tents and the exhibits have been threatened with destruction.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Carbon County, Wyoming, that at the next ensuing general election there be submitted to a vote of the electors of said County the following question, to wit:

"Shall the Board of County Commissioners of Carbon County, Wyoming, be authorized to issue the registered coupon bonds of said County to the amount of Ten Thousand Dollars, bearing interest at the rate of six per cent per annum, payable at the option of the county ten years after date, and payable absolutely twenty years after date, for the purpose of providing suitable buildings and grounds for conducting the annual county fair?"

The motion for adoption of the resolution was duly seconded by County Commissioners Frank Schilt, and on said motion being put the vote of the Board was:

In accordance with the laws of the State of Wyoming and the proclamation of the Governor of the State of Wyoming dated September 12, 1930 and in compliance with the resolution of the Board of County Commissioners dated the 8 day of Oct.
