

COMMISSIONERS PROCEEDINGS NOVEMBER 5, 1930 .

The Board of County Commissioners met this 5th day of November A. D. 1930 at 10 O'clock A. M. Commissioner Chas. Ellis being absent and I. K. Miller in the chair.

COUNTY ROAD

On motion by F. Schilt seconded by I. K. Miller and duly carried the following described Highway was designated as a County Road.

" From the Rocky Mountain Highway near the mouth of Cow Creek , across the new Bridge across the North Platte River, to the present County Road (Mail Road) near Elk Hollow; thence along the present Mail Road to the New Butler Bridge to French Post Office.

Also from a point on the above road at the Brush Creek Ranch Mail Box, along the present public road, to connect with the Saratoga -Ten Mile Road near Buffalo Gulch."

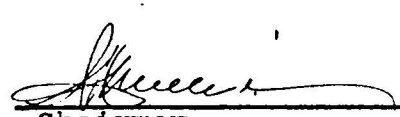
