RESOLUTION

On motion by F. Schilt seconded by I. K. Miller and carried the following resolution was duly adopted:

RESOLUTION REQUESTING DESIGNATION OF FOREST HIGHWAY.

Road
 WHEREAS, the route from Laramie through or near Centennial, Brooklyn Lake, Ten Mile and Saratoga to Walcott and Rawlins is of importance to the people of Albany and Carbon Counties and all of southern Wyoming, and also as a route which has developed and will continue to develop a considerable commercial business and will develop as an

alternate transcontinental route a heavy summer traffic, and

WHEREAS, a portion of this route from Centennial to Brooklyn Lake has heretofore been improved as a forest highway project and the balance of the route from Brooklyn Lake to the western boundaries of the Medicine Bow National Forest has been improved only as a development road and is now inadequate for the present traffic, and

WHEREAS, the improvement of this route from Brooklyn Lake to the western boundaries of the Medicine Bow National Forest to an adequate standard can only be accomplished through the allocation of forest highway funds in sufficient amounts to make possible the type of construction necessary.

THEREFORE, BE IT RESOLVED that this Board of County Commissioners hereby request the State Highway Commission of Wyoming to designate as a forest highway the section from Brooklyn Lake to the western boundaries of the Medicine Bow National Forest and to request the approval of the Secretary of Agriculture of the designation of this route as a forest highway.

The Board thereupon recessed to meet in regular session on Wednesday January 8th at 10 O'clock A. M.

Board resumed its session this 8th day of January A. D. 1930 at 10 O'clock A. M. with I. K. Miller in the chair and Chas. Ellis absent.
