March 16th, 1931.

The Board of County Commissioners met this 16th day of March, A. D., 1931 at the hour of 2 o'clock P. M. in special session for the purpose of considering matters pertaining to the construction of roads within the county. Frank Schilt and Dan C. Kinnaman present, Chairman Schilt presiding.

FOREST PROJECT no. 12 F

Road The board having been advised by the Highway Department that the Bureau of Public Roads expects to let contract for the construction of 5 miles of the Centennial-Saratoga Road this spring, upon motion duly made seconded and carried, the clerk was instructed to publish Notice of Location of Public Road as provided by law.

FEDERAL AID HIGHWAY RAWLINS TO BAGGS

The board having been advised that certain portion of the State Highway Bond issue is to be divided between the various counties of the state, upon motion duly made seconded and carried the following resolution was adopted:

WHEREAS the electors of the State of Wyoming at the Special State Election held in November, 1930 authorized the issuance of its bonds in the amount of \$2,800,000 for the construction of highways within said state, and

WHEREAS a portion of the proceeds of said bond issue is to be apportioned among the several counties of the State of Wyoming for the purpose of construction of highways, and

WHEREAS the Board of Commissioners of the County of Carbon, State of Wyoming, are desirous of establishing and constructing a Federal Aid Highway from the City of Rawlins in said County to the town of Baggs in said county;

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the County of Carbon, State of Wyoming, that the State Treasurer of the State of Wyoming be, and he is hereby authorized and instructed to pay such monies derived from said bond issue and apportioned to said County of Carbon to the Wyoming Highway Department who shall use said funds when matched by the Federal Government as provided by law in constructing a highway from said City of Rawlins to the said town of Baggs.

Nothing further to come before the meeting, same was adjourned.
