A petition signed by 15 citizens of Hanna asking that a road be designated commencing at the Town of Medicine Bow and running in a westerly direction through the town of Hanna and intersecting with the present Lincoln Highway at the Andy Nelson Ranch as provided for in section 2988 Wyoming Compiled Statutes 1920 was filed with the Board and the Clerk instructed by motion duly made and carried to publish initiatory notice in accordance with section 2997 Wyoming Compiled Statutes 1920.

Commissioner M. E. Pickett was appointed as "Viewer" for said proposed public road.

RESOLUTION

The following resolution was adopted on motion duly made and carried:

Resolved by the Board of County Commissioners of Carbon County that that portion of the County Road known as the Encampment-Slater road and designated as road CB-41 be maintained by the State Highway Department and that said said Highway Department present claim to this Board for 50% of said expense, said 50% not to exceed \$400.00 for the year 1931.

APPOINTMENT

Sheriff John McPherson submitted for approval the appointment of R. E. Cooper as Deputy Sheriff at Medicine Bow which appointment was approved by the Board.

Appointment of O. C. Olsen as Deputy Sheriff at Mahoney Dome was also approved by the Board on motion duly made and carried.

Reports of John H. Crawford, Justice of the Peace at Hanna, Laura C. Heath, County Treasurer, Grace A. Rosier, Secretary Carbon County Public Library, John J. McElroy, County Agent, for the month of January, 1931 were approved.

PROCEEDINGS, COUNTY FAIR BUILDING BONDS

The following resolution was introduced:

WHEREAS, at the regular election held in Carbon County, Wyoming, on the fourth day of November, 1930, a majority of the votes cast on the proposition of authorizing the Board of County Commissioners to issue bonds of the county in the sum of Ten Thousand Dollars (\$10,000.00) for the purpose of providing suitable buildings and grounds for conducting the annual county fair, was in favor of such bond issue; and

WHEREAS, it is necessary to publish notice of the sale of such bonds;

THEREFORE, BE IT RESOLVED, by the Board of County Commissioners of Carbon County, Wyoming, that the board shall give notice of the sale of said bonds in the Rawlins Republican, a newspaper published in the county, in Cheyenne Tribune, a newspaper of general circulation published at the capital of the State of Wyoming, in Denver Post, a newspaper of general circulation published in Denver, Colorado, in Chicago Tribune, a newspaper of general circulation published in the City of Chicago, Illinois, and in New York Herald, a newspaper of general circulation published in the City of New York, New York, which notice shall be in substantially the following form, to-wit:

NOTICE OF SALE.

CARBON COUNTY, WYOMING,
FAIR GROUNDS BONDS, \$10,000.

PUBLIC NOTICE is hereby given that on the 2nd day of March, A. D., 1931, at the hour of 10:00 o'clock, A. M., the Board of County Commissioners of Carbon County, Wyoming, will receive sealed bids for the purchase of the fair grounds bonds of said county in the

sum of Ten Thousand Dollars (\$10,000.00). Said bonds will be dated and delivered June 1, 1931, will bear interest at a rate not exceeding six per centum per annum, payable semi-annually, will be in such denominations as may be desired by the purchaser, and will mature (and be optional) as follows: \$1000.00 on first day of June in each of the years 1935 to 1940 inclusive; \$4000.00 any time after 1941.

A certified check on a national bank in the sum of Five (5%) per cent. of the bid shall be submitted, and the amount of such check submitted by the successful bidder will be retained by the county as liquidated damages in the event such successful bidder does not take up and pay for said bonds in accordance with the bid submitted.

The board reserves the right to reject any and all bids.

The county will furnish executed bonds and the approving opinion of Pershing, Nye, Tallmudge, Bosworth and Dick, of Denver, Colorado.
