PETITIONS

The Board of Commissioners were presented with a petition requesting them to open and declare to be a county road, a certain old road from Brush Creek Mail Road at Elwood School House, continuing East via Shellie Wood ranch to the Snowy Range Highway.

A petition was presented requesting the Commissioners to withdraw Leo voting precinct, (Dist. 6 Precinct 1) said petitioners desiring to vote in Hanna. The petition was presented for economical reasons and it was found that by consolidating Hanna and Leo it would then be necessary to divide Hanna into two precincts which would be no saving to the tax-payers. The petitioners were notified no change would be made.

RESOLUTION

The following resolution was passed and a certificate was issued for \$5.00, being Carbon County's part of annual rental for certain lands leased for a stock driveway

R E S O L U T I O N

RESOLVED, That a certain agreement, made and entered into as of the 1st day of January, 1932, by and between the Union Pacific Railroad Company, a corporation of the State of Utah, party of the first part, and the Board of County Commissioners of the County of Carbon, State of Wyoming, party of the second part, with reference to the payment by the Union Pacific Railroad Company of one-half of the rental of certain lands leased by this Board from Susie J. Quealy, Executrix under the Last Will and Testament of Patrick J. Quealy, deceased, be and the same is hereby approved, ratified and confirmed, and that the execution thereof on behalf of said Board of County Commissioners by its Chairman, attested by the County Clerk of Carbon County, by whom the seal of said county has been affixed, be and the same is hereby approved, ratified and confirmed.

AMENDED RESOLUTION

Road

A resolution was made and passed this 6th day of October, amending one certain resolution made September 8th, relative to the connecting link from Baggs-Cherokee road to Baggs Wamsutter road, said resolution is hereby made a part of the records of this office.

WHEREAS, the resolution adopted by this Board on the 7th day of September, 1932, with reference to the construction of a connecting link road from Federal Aid Highway 210-A to the present Wamsutter-Baggs road appears to be incomplete in certain respects, and it is desirable that said resolution should be rescinded and a resolution passed in lieu thereof, setting out said further details,

NOW THEREFORE, be it resolved that in event the proposed Federal Aid Highway, 210A, is constructed to connect to the Lincoln Highway near Cherokee, that the Board of Carbon County Commissioners will construct and maintain a road as a connecting link from said project to the present Wamsutter Baggs road, to be completed and ready for service by the time said Federal Aid Highway is completed to its junction point with said connecting link, said connecting link to be gravelled in the same manner and at the same time as the portion of said Federal Aid Highway is gravelled up to the said junction point.
