SPECIAL MEETING OF THE BOARD OF COUNTY  
COMMISSIONERS OF THE COUNTY OF CARBON.

*Road*

Meeting duly called to order by the Chairman of said Board at 10 o'clock A. M., to consider the report of the appraisers of the Cb Riverside-Colorado Line road; the appraisers of said proposed road, to-wit, I. K. Miller, Fred Hansen and Harry Russell having filed their report as required by law, in the office of the County Clerk of Carbon County, Wyoming, on November 16, 1933, wherein they made a report of their proceedings as such appraisers and fixed the amount of damages to the lands of certain protesting and objecting parties whose lands are traversed by such proposed road.

Said report having been duly considered by the Board, upon motion regularly seconded, it was unanimously approved and ordered placed on file as required by law. Thereafter on motion of D. C. Kinnaman and seconded by Glenn Penland, the following Resolution was unanimously adopted by said Board, to-wit:
