

SPECIAL MEETING OF THE BOARD OF COUNTY COMMISSIONERS

Road

The Board of County Commissioners met this 21st day of May, 1934 at 11:00 A. M. to consider the Appraisers' Report on Riverside-State Line road, pursuant to published notices, and to hear any further petitions or objections against or for the establishment of the road on the proposed right-of-way and objections to damages awarded by the Board of Appraisers and protests against rejection of certain claim for damages.

Petition for Road.

A petition signed by qualified electors of Carbon County for the establishment of a public road known as Centennial-Saratoga road together with a list of owners, mortgagees and parties interested in the land traversed by that portion of the Centennial-Saratoga road proposed to be established was presented to the Board at this time and same was placed on file in the Clerk's office. A right-of-way for this said road was secured by an agreement between the Board of County Commissioners and property owners.
