Sections 6-7-18-19-30-31-T. 21 R 85, were withdrawn from district 5 precinct 1, and added to district 17 precinct 1, Parco, Townships 22-23-24, R. 86 and E $\frac{1}{2}$  twps. 22-23-24 R. 87 were withdrawn from Rawlins district and added to district 17 precinct 1, Parco thereby including in district 17 the following,

Beginning at the S. E. corner of Sec. 31 Twp. 21 R. 85, thence north along section lines to N. E. corner, Sec. 6 T. 21 R. 85, thence west on the north line of Sec. 6 to the Range line between Ranges 85 & 86, thence north along said Range line to Twp. line between 24 and 25 thence west along said Twp. line to the N. W. corner of Sec. 3 Twp. 24 R. 87, thence S. along Sec. lines to the S. W. corner of Sec. 34 Twp. 22 R. 87, thence east along Twp. line between townships 21-22 to R. line between 86-87, thence south along said Range line to the Twp. line between 20-21 thence east on said Twp. line to point to beginning.
