Motion by Frank Schilt, seconded by Eugene McCarthy and carried that the Financial Report Carbon County Fair 1936 be approved and filed.

By resolution of the Board made and carried, the Chairman of said Board was authorized to serve notices on Susie J. Quealy, Executrix under the last will and testament of Patrick J. Quealy, Deceased and on Richards Brothers, Incorporated, for the purpose of renewing, for a period of five (5) years beginning January 1, 1937, those certain leases dated January 1, 1932, from Susie J. Quealy, Executrix to Carbon County and from Richards Brothers, Incorporated to Carbon County.

The hour of 11:00 o'clock A. M. having arrived, the Chairman of the Board announced that the next order of business was receiving, opening and considering bids for the negotiable coupon bonds of Carbon County in the amount of \$30,000.00 for the purpose of providing funds for the erection, construction and completion of an addition to the Carbon County Memorial Hospital located at Rawlins, Wyoming.

Thereupon Linda A. Felton the County Clerk and Clerk of the Board announced that she had received three separate bids for said bonds as follows:

1. The joint bid of The Rawlins National Bank of Rawlins, Wyoming, and The First National Bank of Rawlins, Wyoming.
2. The joint bid of the American National Bank of Cheyenne, Wyoming, and Geo. W. Vallery & Co. Inc. Denver, Colorado.
3. The bid of Harry B. Henderson, Cheyenne, Wyoming.

Thereupon the Board resolved itself into executive session and the representatives of the various bidders retired.

The hour of 12:00 o'clock having arrived and no decision having been reached by the Board on said bids, the Board recessed until the hour of 2:00 o'clock P. M. The hour of 2:00 o'clock P. M. having arrived, the Board resumed its consideration of said bids. Thereupon Commissioner Frank Schilt offered the following Resolution and moved its adoption, to-wit:

"RESOLUTION"

WHEREAS, pursuant to proceedings duly had and taken by the Board of County Commissioners of the County of Carbon, State of Wyoming, the Board did advertise the sale of bonds of the County of Carbon in the amount of \$30,000.00 for the purpose of providing funds for the erection, construction and completion of an addition to the Carbon County Memorial Hospital located at Rawlins, Wyoming, the issuance thereof having been duly authorized by the qualified electors of said county at a special election duly called and held for such purpose, and

WHEREAS, at the time and place mentioned in the aforementioned advertised notice of bond sale, the sealed bids of The Rawlins National Bank of Rawlins, Wyoming, and The First National Bank of Rawlins, Wyoming, jointly, and of the American National Bank of Cheyenne, Wyoming, and Geo. W. Vallery & Co. Inc. of Denver, Colorado, jointly, and the bid of Harry B. Henderson of Cheyenne, Wyoming, have been received and have been duly opened and considered by the Board, and

WHEREAS, the bid submitted by The Rawlins National Bank of Rawlins, Wyoming, and The First National Bank of Rawlins, Wyoming, jointly, for the purchase of said bonds in the amount of \$30,000.00 is in the determination of the Board of County Commissioners the best bid received, and is in excess of the par value of said bonds.

NOW, THEREFORE, BE IT RESOLVED AND ORDERED by the Board of County Commissioners of Carbon County, Wyoming, that the bid of The Rawlins National Bank of Rawlins, Wyoming, and The First National Bank of Rawlins, Wyoming, jointly, in the amount of \$30,000 plus accrued interest plus a premium of \$450.00, be, and the same is hereby accepted, and the sale be, and the same is hereby awarded and the said bonds sold to the said The Rawlins National Bank of Rawlins, Wyoming, and The First National Bank of Rawlins, Wyoming, jointly.

RESOLVED FURTHER, that said bonds shall be in the denominations of \$1,000 each bearing date as of December 1, 1936, and bear interest at the rate of $3\frac{1}{2}\%$ per annum from date of said bonds Payable semi-annually on the 1st day of June and the 1st day of December in each year, said interest to be evidenced by negotiable coupons attached to said bonds. Both the principal of and interest on said bonds shall be payable at the office of the County Treasurer of Carbon County State of Wyoming, in any coin or currency, which on the respective dates of payment of such principal and interest, is legal tender for the payment of public and private debts. Said bonds shall be numbered serially from 1 to 30 inclusive and be absolutely due and payable twenty years from the date thereof, and redeemable at the option of said County ten years after the date thereof. Said bonds shall bear the signature of the Chairman of the Board of County Commissioners, shall be countersigned by the Clerk of the Board of County Commissioners, and shall bear the official seal of Carbon County, Wyoming. The interest coupons attached to said bonds shall bear the engraved facsimile of the signature of the County Treasurer. Each bond so issued shall be registered by the County Treasurer in a book provided for that purpose, which registration shall show the number and amount of each bond, and the name of the person to whom the same is issued.

The County Treasurer of said County shall endorse upon each bond a certificate showing that said bond is issued pursuant to law and is within the lawful debt of Carbon County, Wyoming.

That said bonds and the coupons attached thereto shall be substantially the following form:

By resolution duly made and carried the Chairman of the Board of County Commissioners and the Clerk of said Board were authorized to execute two agreements, pertaining to the stock driveway leases, one between Union Pacific Railroad Company and the Board of County Commissioners for the purpose of extending for a period of five years beginning January 1, 1937 that certain agreement dated January 1, 1932 under which said Railroad Company agreed to pay one-half rental payable by said Board of County Commissioners to Susie J. Quealy, Executrix and the other agreement between Union Pacific Railroad Company and the Board of County Commissioners for the purpose of extending for a period of five years beginning January 1, 1937 that certain agreement dated January 1, 1932 under which the said Railroad Company agreed to pay one-half rental payable by the Board of County Commissioners to the said Richards Brothers, Inc.

THE COUNTY OF CARBON, in the State of Wyoming, for value received, acknowledges itself indebted and hereby promises to pay to the bearer the sum of

ONE THOUSAND DOLLARS

(\$1,000), on the FIRST DAY OF DECEMBER, A. D. 1956, reserving the right to pay the same any time after the FIRST DAY OF DECEMBER, A. D. 1946, with interest thereon at the rate of THREE AND ONE-HALF PER CENTUM (3 1/2) PER ANNUM, payable semi-annually on the FIRST DAY OF JUNE AND THE FIRST DAY OF DECEMBER in each year, both principal and interest payable at the OFFICE OF THE COUNTY TREASURER OF CARBON COUNTY, IN RAWLINS, IN SAID COUNTY, WYOMING, upon presentation and surrender of this bond or of the annexed coupons respectively, as they severally become due, in such coin or currency which on the respective dates of payment of such principal and interest is legal tender for the payment of public or private debts.

THIS BOND is issued by the said County of Carbon for the purpose of providing funds for the erection, construction and completion of an addition to the Carbon County Memorial Hospital located at Rawlins, Wyoming, under and by virtue of, and in strict conformity with the Constitution of the State of Wyoming, Article 10, Chapter 29 of Wyoming Revised Statutes, 1931, and all amendments thereof and all other laws and authority thereunto enabling, and by authority of a vote of the qualified electors of said County present and voting on the question at an election regularly called and duly held in said County for that purpose, prior to the issuance of this bond, at which election a majority of all the said qualified electors assented to the issuance of this bond and the incurring of the debt thereof.

IT IS HEREBY CERTIFIED, that all acts and things required to be done and all conditions required to exist precedent to and in the issuance of this bond to render the same lawful and valid, have been properly done and did exist in due time, form and manner as required by law, that provision has been duly made for the collection of an annual tax sufficient to pay the interest on this bond as it falls due and also to constitute a sinking fund for the payment of the principal thereof within the time required by law, and that the total debt of the said County, including that of this bond, does not exceed any statutory or constitutional limitation of the State of Wyoming.

The full faith, credit and all the taxable property within said Carbon County, Wyoming, are hereby pledged for the punctual payment of the principal and interest of this bond.
