R. Schilt

BE IT RESOLVED, that the County of Carbon, State of Wyoming, through the Board of the County Commissioners of said County, and in accordance with Section 52-107, Wyoming Revised Statutes for 1931, hereby agrees with the Highway Department of the State of Wyoming, to pay one-half of the cost of construction of a fence, with proper gates, on both sides of that certain highway, known as the Centennial-Saratoga Road, Wyoming No. Twelve, commencing at a point on said road project in the SE $\frac{1}{4}$ NW $\frac{1}{4}$ of Section numbered 20, Township numbered 16, North of Range 81, West of the 6th P. M., and terminating at a point in the SW $\frac{1}{4}$ NE $\frac{1}{4}$ of Section numbered 12, Township numbered 16, North of Range 82, West of the 6th P. M., according to the field notes, plat and survey thereof, on file with the said State Highway Department, and further agrees to assume the entire cost of the maintenance thereof.

BE IT FURTHER RESOLVED, that a Certificate of Indebtedness be issued by said County in the sum of \$613.67, payable to the order of James B. True State Highway Superintendent, said amount being the estimated cost of one-half of said construction.
