On motion duly made and carried an abatement of taxes for \$21.93 was allowed Wm. C. Ramelli in District No. 16

Commissioner F. F. Hansen introduced the following resolution and moved its adoption.

Said motion was seconded and unanimously carried.

RESOLUTION.

WHEREAS: Public convenience and necessity requires that a portion of the right-of-way of the Riverside-State Line Highway be widened to a width of 200 feet and it further appears that Federal and State aid cannot be procured by the County for the improvement of this highway unless said right-of-way is so widened, now therefore:

BE IT RESOLVED: That the present right-of-way of the Riverside- State Line Highway be altered and widened to a width of 200 feet in the portion thereof, to-wit:

Beginning at a point in the SE $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 16, T. 14 N. R. 82W., 6th P. M., located N. 40 degrees and 36 minutes W. 1141.6 feet from a point on the Section 16, located N. 89 degrees and 14 minutes E. 592.5 south line of said/feet from the south quarter-corner of said Section 16;
Running thence in a general southeasterly direction along the course of said highway as now established and terminating at a point on the south line of Section 8, T. 13 N., R. 81 W., located east 1224 feet from the south quarter corner of said Section 8.

BE IT FURTHER RESOLVED: That a Viewer be forthwith appointed to view and report upon the widening of said highway, and that notice be given of the alteration and widening of said right-of-way, and further proceedings

be had as prescribed by Chapter 52, Article 2, W. R. S., 1931.

Viewer's Report

The report of S. S. Sharp having been duly filed on December 7th, 1937, the viewer appointed to view and report upon the widening of the Riverside-State Line Highway, was brought up at this time and after due consideration being given, it was moved by F. F. Hansen, seconded by Gus Larson that the present right-of-way of the Riverside-State Line Highway be altered and widened and a notice to that effect be made and advertised in accordance to law.

Whereupon meeting was regularly adjourned until the following day at 10:00 o'clock A. M.
