

## COMMISSIONERS' PROCEEDINGS.

The Board of County Commissioners met this 6th day of April, A. D. 1937, at 10:00 o'clock A. M., with all members of the Board present, Eugene McCarthy, presiding.

A group of resident taxpayers appeared this day before the Board of County Commissioners and submitted the following resolution to be passed and adopted by said Board, to-wit:

"WHEREAS, It satisfactorily appears to the Board that D. R. Higley, the County and Prosecuting Attorney of Carbon County, is attorney for the defendants in that certain case pending in the District Court of Carbon County, Wyoming, entitled Taxpayer's League of Carbon County, Wyoming, plaintiff, vs. John McPherson and United States Fidelity and Guaranty Company, defendants, and that it is desirable that the Board of the County Commissioners of the County of Carbon be made a party plaintiff in said action, and that the said County and Prosecuting Attorney, by reason of his employment by the defendants is disqualified to represent Carbon County in said action.

NOW, THEREFORE, BE IT RESOLVED That the Board of the County Commissioners of the County of Carbon, State of Wyoming, hereby specially employ Harold M. Johnson and N. R. Greenfield as its attorneys to make application to the District Court of Carbon County to be joined as party plaintiff in said action, and to take such other and further proceedings on behalf and in the name of the Board of the County Commissioners of the County of Carbon, State of Wyoming, in said action as said Attorneys may deem requisite or necessary, all without expense to Carbon County."

Mr. Gus Larsen made a motion that said resolution be adopted by the Board of County Commissioners, Mr. Fred Hansen duly seconded said motion.

Mr. Eugene McCarthy called for a vote and upon discussion in the presence of C. L. Bates as special County and Prosecuting Attorney and Harold M. Johnson as representative of the taxpayers submitting the above resolution, it was decided that no vote should be taken upon said resolution at this time, but that the matter should be tabled until the next regular meeting of the Board of County Commissioners for the reasons that Mr. D. R. Higley the duly elected and qualified County and Prosecuting Attorney of Carbon County, Wyoming is absent from the County; that C. L. Bates the special County and Prosecuting Attorney during the absence of Mr. D. R. Higley desires not to pass upon said resolution; that the said resolution should be given mature consideration before being passed and adopted, and that Mr. Harold M. Johnson agreed that said resolution should be tabled and not passed upon until the next meeting of said Board of County Commissioners.

Said matter is tabled and will be given due consideration at the next regular meeting of the said Board of County Commissioners.

The balance of the day was taken up entirely with road delegations from various parts of the County and after disposing of said delegations in a satisfactorily manner, the meeting was regularly adjourned until Wednesday, at 10:00 o'clock A. M.

The Board resumed its session this 7th day of April, A. D. 1937, at 10:00 o'clock A. M., with all members of the Board present, Eugene McCarthy in the chair.
