ELECTION DISTRICTS.

It was moved by Larson and seconded by Hansen that the election districts and precincts should be and remain as established at the regular July 1936 meeting of the Board, with the exception that Marvin precinct number 2, as at present constituted in election district number 4, should be abolished and the election precincts in said election district number 4 are hereby re-established as follows:

- PRECINCT NO. 1 DISTRICT NO. 4
- LAMONT PRECINCT NO. 1, DISTRICT NO. 4 shall consist of all of that part of election district number 4 described as follows:
- Townships 25, 26, 27 and 28 North of Ranges 85, 86, 87, 88 and 89 West; with the polling place <sup>at</sup> ~~and~~ Lamont.
- PRECINCT NO. 2 DISTRICT NO. 4
- SEMINOE DAM, PRECINCT NO. 2 DISTRICT NO. 4 shall consist of all that part of election district number 4 described as follows:
- Beginning at the Southwest Corner of Township 25 North, Range 84 West, thence east to the North Platte River; thence North along the North Platte River to the Section line between Sections 18 and 19, Township 27 North, Range 84 West; thence West along said Section line between said Sections 18 and 19 to the West line of Range 84 West; thence South along said Range line to the Southwest Corner of said Township 25, Range 84, the point of beginning; with the polling place at Seminoe Dam. Motion unanimously carried.

The Board of County Commissioners of the County of Carbon, State of Wyoming, met in regular session at the regular meeting place of said Board on the 8th day of July, A. D. 1938, convening at the hour of 10:00 o'clock A. M., there being present:

Commissioner Larson introduced the following resolution, to-wit:

#### RESOLUTION

BE IT RESOLVED by the Board of County Commissioners of the County of Carbon, State of Wyoming, sitting in regular session at Rawlins, Wyoming, this 8th day of July, A. D. 1938, that the following question be submitted to the qualified electors of Carbon County, Wyoming, at a special election to be held on the 16th day of August, A. D. 1938, the date on which the primary election is to be held within said County, at the regular and legally established polling precincts in said County as designated by the Board for said primary election;

Shall the bonds of Carbon County, State of Wyoming, be issued in an amount of not exceeding One Hundred Sixty Thousand Dollars (\$160,000.00), bearing interest at a rate of not to exceed 3 1/2% per annum, for the purpose of constructing and equipping a County Courthouse and Jail, said Courthouse and Jail to be located

That the polling precincts heretofore created and designated within the County of Carbon, the names, numbers, boundaries and descriptions of which have been fully and legally established, confirmed, published and recorded as the official voting precincts of said County, are hereby designated and reestablished as the official and legal voting precincts for said County for said special bond election to be held August 16th, 1938.

The County Clerk of said County shall provide and furnish to the judges of each of said polling precincts two ballot boxes, to be designated as Ballot Box "A" and Ballot Box "B". Said County Clerk shall also cause to be printed and furnished to the judges of each election precinct, two sets of ballots for the use of the voters entitled to vote at said election, one to be printed on white paper, the other on colored paper and both of which shall contain the same statement of the proposal to be voted upon and the same instructions respecting the manner of marking the ballot. Such judges shall be instructed to furnish to such electors as are not the owners or spouses of the owners of real or personal property assessed on the assessment roll of said County in this state with white ballots, which ballots shall be deposited in Ballot Box "A". If such voter is the owner or spouse of the owner of real or personal property assessed on the assessment roll of said County, he shall be furnished by such judges with a ballot printed on colored paper and the ballots of such persons shall be deposited in Ballot Box "B". And before any person shall be permitted to vote a ballot printed on colored paper he shall be required to make before the officers of such election an affidavit showing that he is the owner or the spouse of the owner of real or personal property assessed on the assessment rolls of said County.

After the close of such election in said respective election precincts the judges thereof shall open said ballot boxes and count the votes therein and determine the result of the election in each ballot box respectively, in such precincts and such determination shall be entered in the proceedings of such boards and certified to the County Clerk of said County in accordance with law.

It shall be the duty of the County Clerk of said County to cause a proclamation and notice of said election to be published not less than thirty days in the Republican Bulletin, of Rawlins, Wyoming, the official newspaper of said County, stating in said proclamation and notice that the election herein ordered will be held on the 16th day of August, 1938, at the places and hours aforesaid, and the purpose for which said election is to be held. 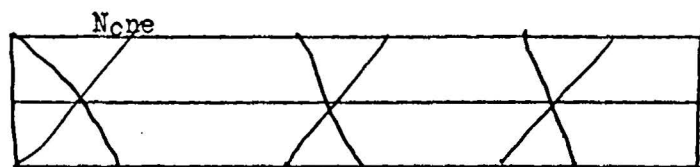
