

Special Meeting

Special meeting of the County Commissioners of Carbon County held at the Court-house of said county at two o'clock P. M., October 24, 1938.

Chairman, Eugene McCarthy, called the meeting to order at two o'clock P. M., and on roll call the following answered present:

The Chairman then announced the purpose of the special meeting was to open and consider bids for the demolition of the existing Courthouse and excavation for the proposed new Courthouse and Jail building, all in accordance with the advertised notice and call for bids.

At the hour of two o'clock P. M. the County Clerk handed to the Chairman three sealed bids and announced that they were all of the bids received. Thereupon said bids were opened and were found to be as follows:
