Commissioner Larson presented and moved the adoption of the following resolution, whereupon said motion was unanimously carried and said resolution adopted to-wit:

"Whereupon a petition was duly filed for the vacation and abandonment of a portion of the County road between the Platt ranch and the Gebhard ranch, and the Board of County Commissioners decided to vacate the same by a resolution passed Sept. 8, 1938;

And whereas said road was viewed and notice of the proposed vacation was duly published and served by registered mail on the land owners involved;

And whereas no protests or claims for damages were filed prior to noon, December 21, 1938, the date specified in the notice;

NOW, THEREFORE, be it resolved that the portion of the County road referred to between the R. H. Platt & Gebhard ranches, as described in the notice, be vacated and abandoned."

The Board of Appraisers having filed their report of the findings, caused by the establishment of the proposed Saratoga-Centennial road, on motion of Gus Larson, seconded by Fred F. Hansen and carried it was decided that no action would be taken at this time in regard to said report and furthermore that each claimant be notified to appear before the Board of County Commissioners January 5th, 1939, whereupon at that time all protests and remonstrances would be heard against the establishment of the said Saratoga-Centennial road.
