

MINUTES OF EQUALIZATION BOARD MEETING
CARBON COUNTY, WYOMING.

The Board of County Commissioners met this 22nd day of May A. D. 1939, at 10:00 o'clock A. M. as provided by Statute, as a Board of Equalization, with all members present, namely, Fred F. Hansen, Chairman, Eugene McCarthy, John F. Gooldy, Wm. A. Johnson, Assessor, and R. G. Engstrom, County Clerk, acting as Clerk for Board of Equalization; all members of this Board were present at the meetings held May 22, 23 and 24, 1939.

The following changes were made:

District No. 2 Mark Meer, Stock sheep raised from 510 to 664 head.

District No. 3 Mrs. Belie Carlson, protested valuation of lots. Lowered from \$175.00 to \$100. Electrical Products Co. Valuation of Neon signs raised from \$68.00 to \$675.00. Jerry O'Driscoll, protested valuation of O'Driscoll camp. No change allowed. Producers Oil & Gas Co., Oil well equipment raised from \$750.00 to \$2000.00. Joe Quinn Sr., Protested assessed valuation of property. No change allowed. Dr. T. J. Swisher, protested assessed valuation on improvements. No change allowed.

District No. 4 Glenn Penland, Range cattle raised from 392 to 525 head.

District No. 5 John Cheesbrough, Bucks, raised from none to 30 head. James H. Gabbott, Coming yearling calves, raised from 40 to 85 head. Hammond Bros., yearling calves raised from 15 to 25 head, stock cattle raised from 25 to 40 head. C. G. Ingemannson, raised from none to 10 grade dairy cows. Frank Makinen, tools and equipment raised from nothing to \$500.00

District No. 6 Chace Bros. Stock sheep, raised from 4360 to 5077 head. Denver Miller, Unfenced grazing land lowered from \$2.00 to \$1.00 per acre. Thos. Wolfe, Improvements raised from \$750.00 to \$1250.00, yearling sheep raised from 750 to 1860 head, stock sheep raised from 3600 to 4580 head, bucks, raised from 65 to 248 head, work horses, raised from 4 to 12 head, saddle horses from none to 4 head, and geldings and mares from 12 to 25 head.

District No. 9 Healey & Anderson, stock raised as follows: Range bulls, 3 to 15 head, stock cattle from 90 to 370 head, horses from none to 6, cow ponies, none to 3 and unbroke mares and geldings, none to 7. Nuhn Grocery, furniture and fixtures raised from \$400.00 to \$800.00.

District No. 13 Joe Quintana, Merchandise, average capital employed raised from \$5.00 to \$100.00

District No. 24 Ralph H. Brokaw, calves raised from 80 to 100 head, and unbroke mares and geldings from 10 to 20 head.

District No. 32 Richards Bros. Inc. Stock sheep raised from 6676 to 7503 head.

District No. 33 Martin & Manning Inc. 1-Rotary rig from \$8325.00 to \$20,000.00

We, the Commissioners of Carbon County and the County Assessor, sitting as the Board of Equalization, hereby certify that we have completed checking and equalizing property values for Carbon County, as listed to date in the tax rolls for the year 1939.

There being no further business to come before the Board, motion was duly made and seconded that the Board adjourn. Unanimously carried.
