The following wage scales in connection with construction of New Court House building were submitted to the Board of Commissioners by the Spiegelberg Lumber and Building Company and approved by the Board.

Vibrator operator 65¢ per hour

Cement mixer operator under 27 cubic feet 65¢ per hour.

Single drum hoist operator 75¢ per hour

TO WHOM IT MAY CONCERN:

The Board of County Commissioners of Carbon County, Wyoming, have decided to locate a road to be known as Wamsutter-Rawlins Road commencing at a point which is S. 0°05' W., 2028.4 feet of the NW Corner of Section 30, T. 21 N., R. 89 W. of the 6th P.M., Wyoming, said point being on the West line of said Section 30, which line is identical with the West boundary of Carbon County, thence in an Easterly direction through Sections 30, 29, 20, 21, 22, 23, 14 and 13, all in T. 21 N., R. 89 W., of the 6th P.M., Wyoming, Sections 18, 17, 20, 21, 22, 23, and 24, all in T. 21 N., R. 88 W., of the 6th P. M., Wyoming, Sections 19 and 18, T. 21 N., R. 87 W., of the 6th P.M., Wyoming, to a point on the East line of Section 18, T. 21 N., R. 87 W., of the 6th P.M., Wyoming, which point is North, 1221.4 feet of the SE corner at said Section 18.

The proposed location and width of right of way required are set forth in detail on Map on file with the County Clerk and may be examined at his office.

All objections thereto and claims for damages must be filed in writing with the County Clerk of said County before noon on the 8 day of August, A. D., 1939, or such road will be established without reference to such objections or claims for damages.
