

SPECIAL MEETING OF THE BOARD OF COUNTY COMMISSIONERS OF
CARBON COUNTY, WYOMING.

Pursuant to the provisions of law, the Board of County Commissioners met this 3rd day of August, A. D. 1939, for the purpose of fixing the tax levies for and within the County of Carbon, State of Wyoming, for the year 1939. There being present Fred F. Hansen Chairman, Eugene McCarthy and John F. Gooldy Commissioners, R. G. Engstrom County Clerk and Wm. A. Johnson, County Assessor.

Having received from the State Board of Equalization notice that the assessed valuation of Carbon County for the year 1939 had been found to be \$25,496,884.00 and that the State tax levy applicable to all assessed property within the State had been fixed at one and one-half mills, (.0015); and that the County Assessor had advised the Board of the assessed valuation of each of the various municipalities and school districts within the County, the Board proceeded to fix the levies upon the assessed property of Carbon County for the year 1939 as follows:
