

## COMMISSIONERS' PROCEEDINGS

## REGULAR MEETING

The Board met this 7 day of May A. D. 1940, at 10 o'clock A. M. all members present Fred F. Hansen presiding.

The minutes of meetings held April 2-8-9-10-18 and 26 were read and approved.

On motion by McCarthy and seconded by Gooldy, the Board decided to postpone the dedication of the new Courthouse until some time after the total completion of the project, from June 8, 1940 to a date to be announced later.

Thereupon the Board adjourned until May 8, 1940.

The Board resumed its session May 8, 1940 at 10 o'clock A. M. Fred F. Hansen presiding.

County Agent Robert R. Peterson announced his resignation to become effective in June 1940.

There being no protest to Malt Beverage License application of A. R. Anderson of Coyote Canyon, motion was made by McCarthy and seconded by Gooldy that license be granted.

A motion was made by McCarthy and seconded by Gooldy that the following banks be designated as County depositories for the year 1940.

First National Bank of Rawlins, Wyoming

Hanna State & Savings Bank of Hanna, Wyoming

Medicine Bow State Bank of Medicine Bow, Wyoming

Saratoga State Bank of Saratoga, Wyoming.

The appointment of Dr. R. M. Leake of Hanna, Wyo. as Deputy Health Officer was approved by the Board upon the recommendation of Dr. R. Barber, County Health Officer.

Mr. E. F. Sullivan was appointed County Engineer Inspector and official correspondent by unanimous action of the Board, to become effective May 15, 1940; to superintend the balance of the unfinished contracts at Courthouse.

*Q.D.H.* A resolution was introduced by McCarthy and seconded by Gooldy, requesting the State Highway Department to complete approximately one-half mile of the Hanna-Elk Mountain Secondary road into the town of Hanna, Wyo. The County further agreed to co-operate with the State on 50% cost basis, for this additional one-half mile of road. Vote resulted as follows: Hansen, McCarthy and Gooldy voting "Aye".

The Board resumed its session May 9, 1940, all members present, Fred F. Hansen, chairman.

On unanimous action of the Board, a resolution was adopted to issue a Quit Claim Deed to the Union Pacific Railroad Company covering parcel of land in Sec. 33, Twp. 22 N., R. 81 W., Carbon County, Wyoming, conveyed by Union Pacific Railroad Company to Carbon County on January 9, 1917 for highway purposes, this strip of land having been abandoned as a highway.

The monthly reports of County officers were audited and approved.

Certificate of Purchase No. 2860 was assigned to Geo. R. Parsons for the sum of \$98.45.

A Quit Claim Deed was issued to M. J. McCune on Lot 11 Block 2, Baggs, Wyo. No fee.

RESOLUTION.

WHEREAS, the Union Pacific Railroad Company by deed dated January 9, 1917, conveyed to The County of Carbon, in the State of Wyoming, a strip or parcel of land in the West Half ( $W\frac{1}{2}$ ) and the Southeast Quarter ( $SE\frac{1}{4}$ ) of Section Thirty-three (33), Township Twenty-two (22) North of Range Eighty-one (81) West of the Sixth Principal Meridian, in Carbon County, Wyoming, which land was acquired by said County for highway purposes; and

WHEREAS, The County of Carbon, State of Wyoming, has requested the Union Pacific Railroad Company to convey to it an easement for right of way for highway purposes over certain lands in the Southeast Quarter ( $SE\frac{1}{4}$ ) and the North Half ( $N\frac{1}{2}$ ) of said Section Thirty-three and has agreed as part consideration therefor to quitclaim to the Railroad Company the said land in the West Half ( $W\frac{1}{2}$ ) and the Southeast Quarter ( $SE\frac{1}{4}$ ) of said Section Thirty-three (33) conveyed to said County by the Union Pacific Railroad Company by the said deed dated January 9, 1917; and

WHEREAS, the Union Pacific Railroad Company has tendered to The County of Carbon, in the State of Wyoming, and The Board of County Commissioners of the County of Carbon, State of Wyoming, a quitclaim deed, identified in the records of the Railroad Company as C.D. No. 24687, whereby The County of Carbon, in the State of Wyoming, and the Board of County Commissioners of the County of Carbon, State of Wyoming, quitclaim to said Union Pacific Railroad Company the following parcel of land, to wit:

A strip of land Sixty (60) feet in width extending across the West Half ( $W\frac{1}{2}$ ) and the Southeast Quarter ( $SE\frac{1}{4}$ ) of Section No. Thirty-three (33) in Township No. Twenty-two (22) North of Range No. Eighty-one (81) West of the Sixth Principal Meridian, the center line of which said Sixty (60) foot strip is described as follows, to wit:

Beginning at a point in the North line of the Northwest Quarter ( $NW\frac{1}{4}$ ) of said Section Thirty-three (33) which said point is Nine hundred (900) feet distant East from the Northwest corner of said Section; thence South Six (6) Degrees, Thirty-seven (37) Minutes West, a distance of One hundred forty (140) feet to a point; thence South Thirteen (13) Minutes West, a distance of Eight hundred twenty (820) feet to a point; thence South Forty (40) Degrees, Twenty-eight (28) Minutes East, a distance of Four hundred eighty (480) feet to a point; thence South Twenty-four (24) Degrees, Twenty-eight (28) Minutes East, a distance of Nineteen hundred ninety (1990) feet to a point; thence South Thirty-six (36) Degrees,

Forty-one (41) Minutes East, a distance of Six hundred eighty-three (683) feet to a point; thence South Forty-one (41) Degrees, Forty-five (45) Minutes East, a distance of Ten hundred seventy-seven (1077) feet to a point; thence South Forty-three (43) Degrees, Thirty-five (35) Minutes East, a distance of Eight hundred ten (810) feet to a point; thence South Eighty-one (81) Degrees, Twenty-seven (27) Minutes East a distance of Two hundred fifteen (215) feet to a point; thence South Seventy-one (71) Degrees, Fifty-seven (57) Minutes East, a distance of One hundred twenty-five (125) feet to a point; thence South Twenty-three (23) Degrees, Four (4) Minutes East, a distance of Two hundred fifty (250) feet to a point in the South line of the Southeast Quarter (SE $\frac{1}{4}$ ) of said Section Thirty-three (33) which said point is Thirteen hundred fifty (1350) feet distant West from the South-east corner of said Section.

The Sixty (60) foot strip of land hereinabove described contains an area of Nine and Eight-hundredths (9.08) acres, more or less;

and

WHEREAS, it appears to the best interest of Carbon County and is conducive to the interest of the inhabitants of said County to quitclaim to the Union Pacific Railroad Company such interest as The County of Carbon, in The State of Wyoming, and The Board of The County Commissioners of The County of Carbon, State of Wyoming, may have in and to the parcel of land hereinbefore described;

THEREFORE, BE IT RESOLVED BY THE BOARD OF THE COUNTY COMMISSIONERS OF THE COUNTY OF CARBON, IN THE STATE OF WYOMING:

That the County of Carbon, in The State of Wyoming, and The Board of The County Commissioners of The County of Carbon, State of Wyoming, execute and deliver to said Union Pacific Railroad Company a quitclaim deed conveying all interest which The County of Carbon, in The State of Wyoming, and The Board of The County Commissioners of The County of Carbon, State of Wyoming, may have in and to the parcel of land described, as aforesaid; and that the Chairman of said The Board of The County Commissioners is hereby authorized, empowered and directed to execute said quitclaim deed on behalf of The

County of Carbon, in The State of Wyoming, and The Board of The County Commissioners of The County of Carbon, State of Wyoming, and that it be duly attested by the County Clerk and Clerk of the Board.
