

Minutes of Equalization Board Meeting  
Carbon County, Wyoming

The Board of County Commissioners met May 27, 1940 at 10:00 A. M. as provided by statute as a Board of Equalization.

Commissioners present:

F. F. Hansen, Chairman  
Eugene McCarthy  
John Gooldy  
R. A. Hakala was appointed clerk of the meeting.

Following complaints were presented to the Board:

J. J. Hickey, representing L. C. and Esther Graves, questioned valuation per front foot on property in business area in city of Rawlins. After due consideration, Board decided to graduate values from \$125. to \$95.00 per front foot, beginning at the corner lots and proceeding to the center of the block.

Board adjourned at noon and reconvened at 2:00 P. M. same day and engaged in routine business. No complaints were presented and board adjourned at 5:00 P. M. to meet the following morning.

Meeting called to order by chairman Hansen May 28th 1940, at 10:00 A. M.  
John Gooldy present, Eugene McCarthy absent.

Robert T. Branham, representing the Sinclair Refining Company appeared before the Board and asked for reconsideration of the schedule used by assessors in valuing large tankage. Board withheld action until they consulted with Mr. Johnson, assessor. Board adjourned for lunch, and met at 2:00 P. M. with all members present. Matter of tankage discussed with assessor, and Board decided to maintain schedule as adopted by the assessors. Notification of action sent to Mr. Branham by registered mail. Communication of Nancy Brown regarding Mountain View lots read and after viewing lots board approved assessment as made. Letter sent to Nancy Brown. Mrs. Anna Donahue appeared before Board and asked for reduction on Encampment lots. After discussion and comparison of values, reduction granted on lots.

The question of assessment of machinery used in mining was discussed, and upon hearing Mr. Johnson, assessor, motion made by Mr. Gooldy, seconded by Mr. McCarthy, and motion carried by unananimous vote of Board, to assess personal property used in mining, Clerk instructed to notify Union Pacific Coal Co. through its agent, Mr. J. A. Brown of the action of the Board. Registered notice sent. Board adjourned at 5:00 P. M. to meet the following morning.
