

COMMISSIONERS' PROCEEDINGS

SPECIAL MEETING

The Board of County Commissioners met September 18, 1940, at 10:00 o'clock A. M., Commissioners Hansen and Gooldy present, McCarthy absent, Fred F. Hansen presiding.

A petition was presented by ten qualified voters from Election District 4, residing at or near Marvin, Wyoming, and vicinity, requesting that a polling precinct be established for the convenience of qualified voters. In compliance with Section 36-1202 Wyoming Revised Statutes 1931, the Board unanimously agreed to establish a polling precinct to be known as Marvin District 4, Precinct 3, and further described as follows:

All of Twp. 25 and 26 N. Ranges 85, 86 and 87 W. of the 6th P. M.

The following Judges and Clerks were appointed by The Board to serve on Election Board in District 4, Precinct 3, Marvin, polling place to be at the school house.

Judges: Hollis Berry, Mrs. Kenneth Govro and Mrs. Mable McCargar.

Clerk: William Burkett and Mrs. Grace Garber.

Petition was also presented by ten qualified voters from Election District 4, residing at or near Station 8, Wyoming, and vicinity, requesting that a polling precinct be established for the convenience of qualified voters. In compliance with Section 36-1202 Wyoming Revised Statutes 1931, the Board unanimously agreed to establish a polling precinct to be known as Station 8, District 4, Precinct 4, and further described as follows:

All of Twp. 27 and 28 N. Ranges 85, 86 and 87 W. of the 6th P. M.

The following Judges and Clerks were appointed by The Board to serve on Election Board in District 4, Precinct 4, Station 8, polling place to be in a bunkhouse.

Judges: D. A. Burtch, Nelson Wayne and Elmer L. Cook.

Clerks: Mrs. A. L. Spurlock and Mr. Alvin M. Clark.

The following correction was made in the boundaries of voting District 4, Precinct 1, Lamont, due to the addition of Precincts 3 and 4 in District 4, and were officially checked by County Surveyor, S. S. Sharp and Attorney, J. J. Hickey.

District 4, Precinct 1, Lamont, shall embrace all of Twp. 25, 26, 27 and 28 N. Ranges 88 and 89 W. of the 6th P. M.

Notice of Location of Public Road

To whom it may concern:

The Board of County Commissioners of Carbon County, Wyoming, have decided to locate a road to be known as the Difficulty-Shirley Road, 80 feet in width, being 40 feet on each side of a center line described as follows:

Beginning at a point on the Medicine Bow-Difficulty Road, in the NW^{1/4} SW^{1/4} of Section 28, Twp. 24, N. R. 80 W., located S 16° 25' E. 3461 feet from the Northwest corner of said Section 28;

Running thence in a general northerly and northeasterly direction through the following described lands:

19' E., 1269 feet from the northwest corner of said Sec. 35;

The total length of said road is 7.24 miles.

Maps showing the location of said road are on file in the office of the County Clerk
of Carbon County, Wyoming, and may be examined at his office.

All objections thereto and claims for damages must be filed in writing with the
County Clerk of said County before noon on the 18th day of October 1940, or such road
will be established without reference to such objections or claims for damages.

There being no further business the Board adjourned subject to the call of the
Chairman.
