ON MOTION BY COMMISSIONER McCARTHY, SECONDED BY GOOLDY AND UNANIMOUSLY CARRIED, A RESOLUTION WAS ADOPTED SETTING ASIDE THE SUM OF \$20,000.00 IN THE ROAD AND BRIDGE BUDGET OF 1941, TO BE MATCHED BY THE STATE HIGHWAY DEPARTMENT FOR THE PROPOSED IMPROVEMENT TO THE BAGGS- DIXON-SAVERY HIGHWAY.

IN COMPLIANCE WITH A RECOMMENDATION OF THE STATE EXAMINER'S OFFICE, THE BUDGET PERIOD FOR 1940 WAS CLOSED NOV. 30, 1940. FUTURE BUDGET PERIODS WILL BE FROM DECEMBER EACH YEAR UNTIL NOVEMBER THE FOLLOWING YEAR. THIS PLACES CARBON COUNTY ON SAME BUDGET PERIOD AS THE MAJORITY OF THE WYOMING COUNTIES.

THEREUPON THE MEETING WAS ADJOURNED UNTIL JAN. 7, 1941.
