The Board of County Commissioners met this 8 day of April A. D., 1940, at 2:00 o'clock P. M., all members present, Fred F. Hansen presiding.

Sealed proposals for the following separate contracts were opened in the presence of The Board, Architect, F. H. Porter; E. F. Sullivan, P. W. A. Engineer; J. J. Hickey; County Attorney and R. G. Engstrom, County Clerk, promptly at 2:00 o'clock P. M.

A- Landscaping B- Construction of Garage C- Walks and Curbing D- Installation of elevator for Carbon County Courthouse and Jail Building.

WHEREAS, Carbon County of the State of Wyoming pursuant to an advertisement for bids on the construction of the following contracts: A- Landscaping; B- Construction of Garage; C- Walks and Curbing; D- Installation of Elevator, heretofore published on the 16th day of March, 1940, did on the 8th day of April, 1940, at 2:00 o'clock, P. M., at its office in Rawlins, Wyoming, receive bids for the construction of the following: A- Landscaping; B- Construction of Garage; C- Walks and Curbing; D- Installation of Elevator, which said bids were taken under advisement by The Board of County Commissioners; and
